Dear Robert Jones:

This notice announces the December 4, 2025, expiration of the Citrus Crop Group 10-10 uses on the above-listed products registered under FIFRA Section 3. This notice provides for disposition of existing stocks of the product bearing labeling with the Citrus Crop Group 10-10 uses. The Agency considers the expiration of a time-limited registration or a time-limited use that is part of a registration to be a cancellation or use termination under FIFRA Section 3, for purposes of permitting sale or use of existing stocks in accordance with FIFRA Section 6(a)(1). Any distribution, sale, or use of existing stocks of the product bearing labeling with terminated uses in a manner inconsistent with any of the Provisions for Disposition of Existing Stocks set forth below will be considered a violation of FIFRA Section 12(a)(2)(K).

Pursuant to 40 C.F.R. § 152.130(b), a registrant may distribute or sell a product under labeling bearing any subset of the approved directions for use, provided that in limiting the uses listed on the label, no changes would be necessary in precautionary statements, use classification, or packaging of the product. Accordingly, you may distribute and sell the above-listed product under previously approved labeling, provided that the Citrus Crop Group 10-10 uses are removed and all other requirements of § 152.130 are met. EPA requires that you submit, as a non-PRIA label amendment, a revised copy of the label for the above-listed products with the Citrus Crop Group 10-10 uses removed.

Pursuant to the terms set forth below, EPA is allowing the sale, distribution, and use of existing stocks of the above-described registration subject to the use cancellation through the expiration date of December 4, 2025. For purposes of this order, existing stocks are those stocks of the pesticide products with cancelled uses that are currently in the United States and

were packaged, labeled, and released for shipment prior to the December 4, 2025 expiration date. This order includes the following existing stock provisions:

- The registrant may continue to sell or distribute existing stocks of EPA Registration Nos. 91275-2, 80990-1, and 80990-6 subject to the use cancellation that were released for shipment on or before December 4, 2025, bearing appropriate previously-approved labeling.
- Persons other than the registrant may continue to sell or distribute existing stocks of EPA Registration Nos. 91275-2, 80990-1, and 80990-6 subject to the use cancellation until supplies are exhausted, provided that products contain the previously-approved labeling and that products were released for shipment by the registrant on or before December 4, 2025. Any person may continue to use existing stocks of EPA Registration Nos. 91275-2, 80990-1, and 80990-6 subject to the use cancellation until supplies are exhausted provided that such use is consistent with the terms of the previously approved labeling.
- Any person may continue to use existing stocks of EPA Registration Nos. 91275-2, 80990-1, and 80990-6 subject to the use cancellation until supplies are exhausted provided that such use is consistent with the terms of the previously approved labeling.

This letter does not affect any additional conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them. However, releasing these products for shipment constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.
