Thermal Applications: This product can only be used the Skeet-Daddle TM Fogging Machine, which is sold separately. Skeet-Daddle fogging Insecticide is to be used undiluted.

Do not apply directly to or near water, storm drains, or drainage ditches. Do not apply when windy. To prevent run-off, do not over water the treated area(s) or apply when heavy rain is expected.

For reduction in annoyance from Mosquitoes, Houseflies, Gnats, Fruit Flies, Wasps, Hornets and Yellow Jackets in residential/homeowners'yards and on patios, as well as around swimming pools. Hold thermal applicator at least five (5) feet from any object, especially plants and shrubbery. Avoid wetting any plant foliage. Apply undiluted at the rate of 3 gallons per acre. Fog only when there is no breeze, or when the wind velocity is less than 3 miles per hour. If windy, use with wind directed towards the applicator's back. The ideal time is generally at dusk when the wind dies down and the air and ground temperatures are approximately the same. Under these conditions the fog will linger in the treated area for a longer time. Apply fog while moving away from the treated area. Avoid inhalation of the fog. Do not enter the treated area until the fog has dissipated. Repeat application if the insects return.

Do NOT leave the fogging machine unattended with the engine running.

The maximum treatment allowed per year is 42 gallons/acre of the undiluted product.

STORAGE & DISPOSAL

Storage: Store product in original container in locked storage area at room temperature above 32°F. Unscrew the canister from fogger machine if it will not be used for an extended period of time and snap the CRP cap back onto the cannister.

Container Disposal: If empty, do NOT reuse this container. Place in trash or offer for recycling if available. If partly filled, call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
