
The amendment referred to above, submitted in connection with registration under Section (3) (c) (7) (a) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Change "products" to fabric/apparel throughout the labeling.
2. Move the misuse statement, "It is a violation of federal law.... etc. so that it appears above the bulleted items.

Since this label has been identified as the master label submit also the hang tag and garment labels. Note that these labels must be revised in accordance with comment 1 above.
