ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish, aquatic invertebrates, birds and mammals. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product into sewer systems without previously notifying the local sewage treatment authority. DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

MICROPEL 5 PVC is a formulation of 10,10'-oxybisphenoxarsine specifically designed for compatibility with flexible vinyl systems. It may also be used as a preservative in plastic products, floor and wall coverings, coated fabrics for upholstery, shower curtains, mattress covers.

A level of 0.6% MICROPEL 5 PVC based on total weight of the final treated product will give excellent control against bacteria and mold organisms in treated articles. For certain items which may be subjected to extended outdoor weathering, such as marine upholstery, swimming pool liners, tarpaulins, landau tops, a level of 1% should be evaluated.

Do not use MICROPEL 5 PVC where treated plastic materials can come in contact with humans or pets or be used as food or feed packing material or as food contact surfaces.

NOTE: Please refer to instructional bulletins for additional information on the use of this product.

STORAGE & DISPOSAL

Do not contaminate water, food, or feed by storage.
PESTICIDE STORAGE: Do not store in the presence of food or feed. OBPA that cannot be used according to label instructions must be disposed of according to Federal or approved State procedures under subtitle C of the Resource Conservation and Recovery Act (RCRA).
PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA regional office for guidance.

IF INHALED:	<ul style="list-style-type: none"> • Move person to fresh air. • If person is not breathing, call 911, or an ambulance, then give artificial respiration preferably by mouth-to-mouth, if possible. • Call a poison control center or doctor for further treatment advice.

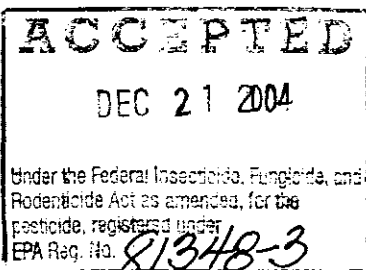
