CAUTION

FIRST AID

IF IN EYES:	<ul style="list-style-type: none">• Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing the eye.
IF ON SKIN OR CLOTHING:	<ul style="list-style-type: none">• Take off contaminated clothing.• Rinse skin immediately with plenty of water for 15-20 minutes.• Call a poison control center or doctor for further treatment advice.
IF INHALED:	<ul style="list-style-type: none">• Move person to fresh air.• If person is not breathing, call 911, or an ambulance, then give artificial respiration preferably by mouth-to-mouth, if possible.• Call a poison control center or doctor for further treatment advice.

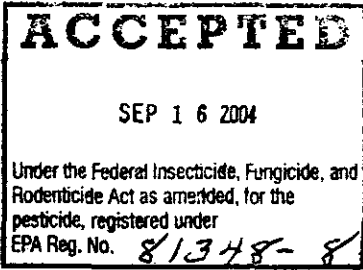

ENVIRONMENTAL HAZARDS
This pesticide is toxic to fish, aquatic invertebrates, birds and mammals. MICROPEL IT 10 PVC is a formulation of 2-n-octyl-4-isothiazolin-3-one specifically designed for compatibility with flexible vinyl systems. It may also be used as a preservative in plastic products, floor and wall coverings, coated fabrics for upholstery, shower curtains, mattress covers.

A level of 1.2% MICROPEL IT 10 PVC based on total weight of the final treated product will give excellent control against mold organisms in the treated articles. For certain items which may be subjected to extended outdoor weathering, such as marine upholstery, swimming pool liners, tarpaulins, landau tops, a level of 2% should be evaluated.

Do not use MICROPEL IT 10 PVC where treated plastic materials can come in contact with humans or pets or be used as food or feed packing material or as food contact surfaces.

NOTE: Please refer to instructional bulletins for additional information on the use of this product.

STORAGE & DISPOSAL
Do not contaminate water, food, or feed by storage.
PESTICIDE STORAGE: Do not store in the presence of food or feed. OBPA that cannot be used according to label instructions must be disposed of according to Federal or approved State procedures under subtitle C of the Resource Conservation and Recovery Act (RCRA).
PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law.
