

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**IMPORTANT:** Keep out of reach of children. Do not place in areas accessible to children.

Use Restrictions: To kill clothes moths (eggs, larvae, and adults) and carpet beetles in clean, air-tight containers (e.g. chests and trunks), garment bags, and storage closets. Do not use in containers, dry cleaning and garbage bags, or closets that allow vapors to escape into occupied rooms. Do not use this product with any other moth control chemical. Do not use in plastic storage containers or in contact with plastic items as paradichlorobenzene damages some plastics. For use only on cloth containing wool or wool blends in fabrics, silks, blended fabric, and furs.

**Pre-Application Directions:** Clean or thoroughly brush articles before storing.

Application Directions: Remove cellophane wrapper. Use one ounce of [IMS MOTH CAKE] [SMART LIVING MOTH CAKE] for every 3 cubic feet of tightly enclosed space. Place cake in plastic holder and hang in garment bag or over coat hanger. As chemical is used up, replace with new unit. Apply [IMS Moth Crystals] [Smart Living Moth Crystals] in clean, air-tight containers, bags and closets at the rate of 1 lb. for each 48 cubic ft. of contained spaces.

To determine the appropriate ounces of product needed, multiply the height, width, and depth of the space (measured in feet) and divide by 3. For example, a closet 8 feet high, 4 feet wide, and 3 feet deep is 96 cubic feet, divided by 3 ft<sup>3</sup>/oz. of product, equals 32 oz. of product needed to adequately treat the area.

**Post-Application Directions:** Keep product in air-tight space for a minimum of seven (7) days. Odor dissipates when treated articles are aired.

**Retreatment:** Since moths are active all year, replenish air-tight containers, bags, and closets two (2) times a year.
