Amended labeling to add an alternate brand name and make other minor changes

IMS Moth Crystals

The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, is acceptable with the following comments:

- On page 2, under the directions for use, replace the word "should" with "must" and add the following text so the last statement reads, "Paradichlorobenzene moth crystals must not be mixed or placed in contact with other moth preventive products or chemicals." (The word "should" implies that this restriction is advisory, not mandatory.)
- On page 2, the last two statements (restriction against mixing with other moth preventive products and restriction against storing in plastic containers) under the directions for use must be presented as a separate paragraph, rather than under the Rugs and Carpets section, as these statements are applicable to all uses of the product, not just rugs and carpets.

Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on non-refillable containers. The code may appear either on the label or durably marked on the container itself. This information can be added by non-notification per PR Notice 98-10.

A stamped copy is enclosed for your records. The alternate brand name "Smart Living Moth Crystals" has been added to our records. Please submit two copies of your final printed labeling before you release the product for shipment. Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e).
