- c. Under the "Pesticide Storage" heading, third sentence, delete the word "connect" and add the word "correct". The sentence should read, "Carefully collect and contain...."
- d. Under the "Plastic Containers" heading, second sentence, add the word "or" after the word "landfill". Delete the word "or" after the word "incineration". Also, delete the phrase, "by burning" and end the sentence with a period after the word "authorities". The second sentence should read, "Then offer for recycling or reconditioning, or puncture and dispose of container in a sanitary landfill, or by incineration if allowed by State and local authorities."
- e. Under the "Metal Containers" heading, second sentence, delete the word, "purchase" and replace it with the word "puncture". Also, add the term "container" before the phrase "in a sanitary landfill,..." The sentence should read, "Then offer for recycling or reconditioning, or puncture and dispose of container in a sanitary landfill, or by other procedures approved by State and local authorities."
- 3. Submit a one year storage stability study (Guideline # 830.6317) by December 2007.
- 4. Submit one copy of the final printed label before the product is released for shipment.
