The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped “NOTIFICATION” and placed in our records.

The primary brand name, “**Albaugh Tebuconazole Technical**” has been added to the product record.

Should you wish to add/retain a reference to the company’s website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) and is subject to review by the Agency. Asparagus, Bananas, Barley (seed treatment and foliar application), Beans, Brassica leafy greens subgroup 5B, Bulb vegetable crop group 3, Corn, Cotton, Cucurbit vegetables crop group 9, Fruiting vegetable crop group 8, Garden beets, Grapes, Grasses grown for seed, Hops, Lychee, Mango, Oats (seed treatment and foliar application), Okra, Peanuts, Pistachio, Pome Fruit crop group 11, Soybeans, Stone Fruit crop group 12, Sunflower, Tree Nuts crop group, Turnips, and Wheat (seed treatment and foliar application).

Terrestrial Non-Food Crops:

Roses, Flowers, Ornamental trees, Ornamental shrubs, Groundcovers and Vines, Houseplants, and Golf Course Turf.

Terrestrial Non-Food (Domestic Outdoor):

For the preservation of wood-based composite products, wood products intended for above ground and in-ground contact, plastics, paper coatings indoor, non-food contact uses, glues and adhesives, sealants and metal working fluids against biodeterioration.
