- f. Under Terrestrial Food Crops, add the use site "triticale", since wheat is a registered use.
- g. Due to the acute toxicity profile, the signal word, Spanish, First Aid, and Hazards to Humans and Domestic Animals statements are optional for this product.
- h. Change the heading from "Hazardous to Humans and Domestic Animals" to "HAZARDS TO HUMANS AND DOMESTIC ANIMALS".
- i. Change the PESTICIDE DISPOSAL statement to read "Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility." since this product is not acutely hazardous.
- j. Change the CONTAINER DISPOSAL section by removing the statement for Metal Containers, since this container type is not listed on the application Form 8570-1.


- 1. Terrestrial Food Crops: Wheat, barley, oats, cotton, canola, flax

- 4. Uses for experimental purposes that are in compliance with USEPA requirements.




