- 3. Uses for which the U.S. EPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration.
- 4. Uses for experimental purposes that are in compliance with U.S. EPA requirements.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store Rotam Tribenuron-methyl Technical in a cool, dry place away from food, drink, and animal feeding stuffs. If spilled, do not flush to waterways (see Environmental Hazards). Carefully collect and containerize spilled material in a manner that produces the least amount of airborne dust.
