The primary brand name of this product has been changed from Rotam Tribenuron-methyl Technical to Albaugh Tribenuron-methyl Technical, and our records have been updated accordingly.

- 2. Terrestrial Feed Crops or Non-Food Use: Fallow, grass
- 3. Uses for which the U.S. EPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration.
- 4. Uses for experimental purposes that are in compliance with U.S. EPA requirements.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store Rotam Albaugh Tribenuron-methyl Technical in a cool, dry place away from food, drink, and animal feeding stuffs.
