The EPA has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The labeling submitted with this application has been stamped "Notification" and will be placed in our records.

The primary brand name of this product has been changed from Rotam Clethodim MUP to Albaugh Clethodim MUP, and our records have been updated accordingly.
