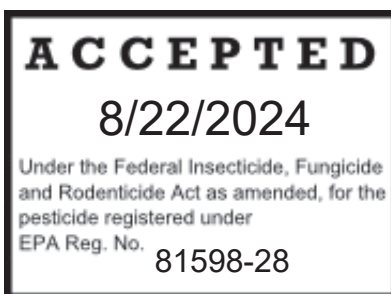

Offer for recycling, or puncture and dispose of in a sanitary landfill, or if allowed by State and local authorities, by burning. If burned, stay out of smoke.
