Restriction: Use on succulent green beans as a food crop is prohibited (includes string beans, snap beans and wax beans). Succulent green bean use is permitted ONLY if grown for seed.

<u>Terrestrial Non-Food Uses:</u> wasteland, shrubs, trees, Christmas trees, flowering crabapples, crape myrtle, dichondra, turfgrass (use limited to sod farms and golf courses, except when applying by mound or spot treatment for fire ant and harvester ant control), daisies, dahlias, Easter lily, gladioli, gypsophila, pachysandra, peony, roses, sedum, statice, strawflower, yarrow, zinnia, container grown nursery stock (arborvitae, azalea, camellia, rhododendron, roses, viburnum), and tobacco.

<u>Outdoor:</u> wasp nests, perimeter treatment, buildings, window frames, shutters, entry ways, screens, eaves, patios, garages, carports, and garbage areas.
