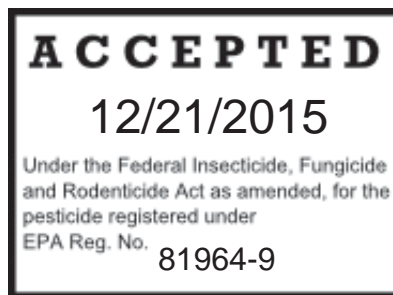

- (1) Terrestrial Food/Feed Crops: Asparagus, Caneberry (Crop Subgroup 13-07A), Bushberry (Crop Subgroup 13-07B), Cranberry, Field Corn, Flax, Grasses grown for seed, Millet, Oats, Okra, Popcorn, Production Seed Corn, Rhubarb, Silage Corn, Sorghum, Soybean, Sugarcane, Sweet Corn;
- (2) Terrestrial Non-food Crops: commercial, institutional and residential ornamental turfgrass, sod farms;
- (3) Uses for which US EPA has accepted the required data or citations of data that the formulator has submitted in support of registration, and
- (4) Uses for experimental purposes that are in compliance with US EPA requirements.

Each formulator is responsible for obtaining EPA registration for their end-use product(s).

STORAGE AND DISPOSAL
