- (1) Terrestrial Food/Feed Crops: Asparagus, Caneberry (Crop Subgroup 13-07A), Bushberry (Crop Subgroup 13-07B), Citrus Fruit, Cranberry, Field Corn, Flax, Grasses grown for seed, Millet, Oats, Okra, Pearl Millet, Pome Fruit, Popcorn, Production Seed Corn, Rhubarb, Silage Corn, Sorghum, Soybean, Stone Fruit, Sugarcane, Sweet Corn, Tree Nuts;
- (2) Terrestrial Non-food Crops: commercial, institutional and residential ornamental turfgrass, sod farms;
- (3) Uses for which US EPA has accepted the required data or citations of data that the formulator has submitted in support of registration, and
- (4) Uses for experimental purposes that are in compliance with US EPA requirements.

Each formulator is responsible for obtaining EPA registration for their end-use product(s).
