Dry treated areas and articles such as clothing before use. Remove children and pets from treated area until completely dry. Clean surfaces prior to application.

Do not use in any application involving direct or indirect food or drinking water contact.

For Pump Spray Application: Dilute 8 ounces of DURALAST per gallon of water (2 oz. per quart; 1oz. per pint). Using pump sprayer, spray entire area 4"- 6"s from the surface making sure the surface is completely covered. Apply and then let stand until dry or let stand 3 minutes and wipe dry with cloth or sponge. If spotting occurs, wipe with moist cloth or sponge.
