

AgSil<sup>®</sup> 25 is a broad spectrum preventative fungicide recommended for agricultural crops, fruits, nuts, vines, turf and ornamentals. Optimum disease control is obtained when the fungicide is applied on a regularly scheduled preventative spray program. AgSil® 25 also provides suppression of mites, aphids, whiteflies and other insects. Optimum performance is achieved using a sufficient volume of water to insure complete coverage of all stems and foliage.

AgSil® 25 is for use on Ornamental Turf Lavins (Residential, Industrial and Institutional), Parks, cemeteries, Athletic Fields and Goif Courses (Fairways, Aprons, Tees, and Roughs), and similar turf areas. Also for use on Sod Farms,

Since all combinations or sequences of pesticide applications including surfactants and adjuvants have not been tested, before wide spread application, test a small area to be sprayed first to make certain that no phytotoxicity occurs.

### **MIXING INSTRUCTIONS:**

Be sure the sprayer is clean and not contaminated with other materials prior to use. When using an agitated spray tank fill tank 1/2 to 3/4 full with clean water and start agitation. Be certain that the agitation system is working properly. With the agitator running add the required amount of AgSil® 25 to the tank. If tank mixing with other materials, add them to the tank and continue agitation. Continue filling tank with the remainder of the water. Agitate until mixed thoroughly and avoid excessive foaming. Mix as needed; do not store diluted material.

### **COMPATIBILITY:**

AgSil® 25 is compatible with most commonly used agricultural pesticides. If compatibility is in question, use the compatibility jar test before mixing a whole tank. Dilute AgSil® 25 to its use rate and then with stirring add the other components in the appropriate amounts. If precipitation, gelation, or sedimentation occurs, do not use the combination of pesticides. Because of the wide variety of possible combinations that can be encountered, observe all precautions and limitations on the label of all products used in mixtures.

### **APPLICATION INSTRUCTIONS:**

AgSil® 25 is a broad spectrum pesticide for control of the fungal disease powdery mildew, and suppression of mites, aphids, whiteflies and other insects on vegetables, fruits, nuts, vine crops, agronomic crops, and ornamentals; for control of gray mold rot (*Botrytis cinerea*) on blueberry; for suppression of Asian soybean rust on soybean, and for suppression of gray leaf spot, brown patch, dollar spot, and snow mold on turf. Rate of application is variable according to pest pressure, timing of sprays and plant stage of growth. Use lower rates under light to moderate pest pressure; higher rates under heavy pest pressure and for mite suppression. Arid climates generally require higher rates.

For all crops, apply AgSil® 25 at a volume to volume concentration of 0.5% to 1% spray solution, unless otherwise specified. For example, 2-4 guarts per 100 gallons of water. See Dilution Table for other volumes. Apply on a preventative schedule for disease control. Begin applications when environmental conditions are conducive to disease development. Repeat applications no sooner than every 7 days. When conditions are conducive for rapid disease development, it is recommended that AgSil® 25 be used in a rotational program with other registered fungicides. For mite and insect suppression, begin applications when pests first appear and repeat applications as necessary to maintain suppression, but no sooner than every 7 days. For best results, apply AgSil® 25 before leaf hardening.

For maximum results, use a high analysis non-ionic surfactant such as No-Foam A at recommended label rates.

### SUPPLEMENTAL LABELING Sil-MATRIX FUNGICIDE/MITICIDE/INSECTICIDE

### Chemigation Application Instructions GENERAL INFORMATION:

Apply this product only through drip (trickle); sprinkler (solid set, lateral move, end tow, sideroll, center pivot, or hand move); flood (basin); furrow; or border irrigation systems. Do not apply this product through any other type of irrigation system.

Crop injury or lack of effectiveness can result from non-uniform distribution of treated water.

Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place.

A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.

Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.

Chemigation systems connected to public water systems must contain a functional, reduced pressure zone, back flow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, discharge the water from the public water system into a reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection.

The pesticide injection pipeline must contain a functional, normally dosed, solenoid operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.

The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops, or in cases where there is no water pump, when the water pressure decreases to the point where pesticide distribution is adversely affected.

Systems must use a metering pump, such as a positive displacement Injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

Do not apply when wind speed favors drift beyond the area intended for treatment.

### **DRIP TRICKLE CHEMIGATION:**

- 1. The system must contain a functional check valve, vacuum relief valve and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
- 2. The pesticide injection pipeline must contain a functional, automatic, quickclosing valve to prevent the flow of fluid back toward the injection pump.
- The pesticide injection pipeline must also contain a functional, not mally closed, solenoid-operated valve focated on the intake side of the injection pump and connected to the system interlock to the system i

the supply tank when the irrigation system is either automatically or manually shut down.

- 4. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- 5. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- 6. Systems must use a metering pump such as a positive displacement injection pump (i.e., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

- 2. The pesticide injection pipeline must also contain a functional, automatic, quickclosing check valve to prevent the flow of fluid back toward the injection pump.
- 3. The pesticide injection pipeline must also contain a functional, normally closed,

solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.

- 4. The system must contain functional Interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- 5. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- 6. Systems must use a metering pump such as a positive displacement injection pump (i.e., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

- 8. Do not apply when wind speed favors drift beyond the area intended for treatment.

# FLOOD (BASIN), FURROW AND

1. Systems using a gravity flow pesticide dispensing system must meter the copesticide into the water at the head off the field and downstream of a hydraulic

discontinuity such as a drop structure or wear box to decrease potential of water source contamination from the backflow if water flow slops.

- 2. Systems utilizing a pressurized water and pesticide injection system must meet the following requirements:
  - a. The system must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
  - b. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
  - c. The pesticide injection pipeline must also contain a functional, normally closed, solenoidoperated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
  - d. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
  - e. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
  - f. Systems must use a metering pump, such as a positive displacement injection pump (i.e. diaphragm pump), effectively designed and constructed of materials that are

compatible with pesticides and capable of being fitted with a system interlock.
