On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A), provided that you:

- Submit and/or cite all data required for registration/reregistration of your product 1. under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of you product under FIFRA section 4.
- 2. Make the following labeling changes:
 - Revise the EPA Registration Number to read "EPA Reg. No. 82108-1" a)
 - The draft labeling appears to be the hang tag label that will appear on the outside **b**) of the gear or item. Please clarify. If this labeling will not be permanently affixed to the treated gear then you must submit the specific labeling that will appear on each item impregnated with permethrin. The labeling must carry similar wording as indicated on the label for treated clothing. In addition the following statement must appear on the outer label "Retain this label for future reference on proper handling of this item. This tag not to be removed except by consumer"

- Delete the claim for effectiveness for one year of exposure to weathering for non washable items. Data mut be submitted using treated gear representing a range of fabric types and aged for one year.
- Delete picnic table cloths. Permethrin is not approved for use on surfaces that may come in direct contact with food or feed. Also delete outdoor furniture covers, outdoor furniture cushion covers, ground cloths and personal flotation devices. These sites are not listed on the source product label.
- Delete the following optional marketing claims:
 - "Including those which may carry West Nile virus"
 - "Including those which may carry Lyme disease"
 - "Or related reactions or diseases"

Efficacy data must be submitted with the treated gear using known vectors of the disease. Supporting data for at least two important vectors of the disease from different genera would be acceptable.

- "No bugs, no bite"
- "Eastern Insect Repellent Gear is to bugs what Gore-Tex is to rain"
- "The insect repellent alternative"
- "A revolution in personal insect protection"
- "You can't tell it's there but the bugs can"
- "No matter where you go, you are going to be in bug country"

Words or phrases that a product possesses unique characteristics because of its composition; heightened claims of efficacy or claims stating or implying complete control; false or misleading comparisons with other pesticides; vague or non specific terms implying unstated benefits are not acceptable.

- Either delete the third bullet under Optional Marketing statements or revise to read, "Eastern Insect Repellent Gear cannot guarantee complete protection from insects and insect bites".
- 3. Phease submit two (2) copies of your final printed label for before your release the product for shipment. Please refer to the A-79 enclosure for a further description

of final printed labeling. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.
