- Delete the term "CROP" on page 4.

Turf and Garden Seven % Granular Carbaryl Insecticide is a granular formulation of carbaryl that may be applied by a properly calibrated push type spreader.

For areas less than 1000 square feet, a shaker container may be used. If a shaker can is used, generally a container capacity of 1 to 3 pounds is sufficient. Consult the specific Use Directions for appropriate amounts of this product to scoop or pour from the product container into the shaker can. Do not apply product by hand, spoon or by using a belly grinder.

Apply when air is calm. For plants above chest height, consider using a liquid carbaryl product. Do not apply this product in a way that will contact any person or pet, either directly or through drift. Keep people and pets out of the area during application.

Do not allow people or pets to enter treated area until dusts have settled.

Product must be watered in immediately following application to lawns.

Do not allow people (except those involved in watering-in) or pets to enter the treated area until the watering-in is completed and the area has dried.

Not for use on plants grown for sale or commercial use, research, or commercial seed production. For outdoor use only.

# TO KILL TICKS WHICH MAY VECTOR LYME DISEASE

To kill juvenile and adult *Ixodes spp.* ticks (Deer tick, Bear tick, and Black legged tick) and *Amblyomma spp.* ticks (Lone star tick), apply granules at the rate of 0.35 pounds of formulated product per 1000 square feet. Will only kill ticks that are present at the time of application. Ticks must be directly contacted to be effective:

Begin applications in late spring or early summer (May/June). Apply the product uniformly across the entire lawn, perimeter wooded areas, and property boundaries including shrub beds, ornamental plantings, and wooded areas where exposure to ticks may occur. Irrigate treated areas immediately after application to remove chemical from granules. Repeat applications as needed up to a total of 4 times per year. Do not apply more often than once every week.

#### TO KILL NUISANCE PESTS

For use in and around flower beds and ornamental plantings and around the outside of homes, porches, patios, and storage sheds. Will only kill listed target pests that are present at time of application. Pests must be directly contacted to be effective. Repeat applications as needed up to a total of 4 times per year. So not apply more often than once every week.

Water lightly after application to release the chemical from the granules.
