Perimeter ETO Insect Guard Concentrate is for formulation into end-use pesticide products, for use on military garrison/combat/working uniforms ONLY by U.S. Military Personnel.

All end-use products require their own U.S. EPA registration. Finished products containing Perimeter ETO Insect Guard Concentrate may not make public health pest claims without an EPA pesticide registration.

Application limited to outerwear (outer blouse and trousers) of military garrison/combat/working uniforms only. Do not apply to undershirts, underwear, or other items.

Apply at a rate of 1.81% by weight of outer uniform materials to achieve a 0.90% etofenprox by weight of uniform. Must be used with proprietary inert ingredients sold by Pine Belt Processing and the proprietary Pine Belt Processing application process. The user of this MUP must obtain inerts from Pine Belt Processing in order to formulate an end-use product. The efficacy data related to this registration is based on the proprietary formulation owned by Pine Belt Processing.

Mix the following products together to achieve a total mix weight of 70% of the untreated weight (lbs.) of the dry garment(s)/textile(s). Example: For 100 lbs. of dry garment, mix 65.7 lbs. of water, 1.0 lbs. of Proprietary Inert 1 sold by Pine Belt Processing, 1.5 lbs. of Proprietary Inert 2 sold by Pine Belt Processing, and 1.8 lbs. of Perimeter ETO Insect Guard together. Use the equation in Table 1 to calculate the proper amounts of ingredients to use based on your total weight (lbs.) of dry garment/textile.

Apply total mixture calculated above by using the Pine Belt Processing application process to achieve a 0.90% etofenprox by weight per dry garment/textile.
