2) To the Directions for use add "The minimum interval between applications is to be no less than 5 days."

3) Per the acute toxicity review, the heading "IF ON SKIN" in the first aid statements must be revised to read "IF ON SKIN OR CLOTHING."

4) Since separate handler PPE text appears on the label (top of Page 2), the text "Wear longsleeved shirt and long pants, socks, shoes, and chemical-resistant gloves (such as Natural Rubber, Selection Category A)" should be deleted from the Hazards to Humans and Domestic Animals statements currently on the label.

5) Per the NAA RED label table, the text in **bold type** below must be added to the following User Safety Requirements:

"... If no such instructions for washables exist, use detergent and hot water..."

6) Per the RED, the text "User should remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing" must be added to the User Safety Recommendations section.


