3. Make the following label changes:
 - a. Under Storage and Disposal, revise the first bullet to read "**Pesticide Storage**".
 - b. Under Hazards to Humans and Domestic Animals, add "Wear: Long-sleeved shirt and long pants, socks, shoes and gloves."
