2. Make the following changes to the label:
  - a. Change the product registration number to "EPA Reg. No. 82542-19"
  - b. On page 2 in the section **HAZARDS TO HUMANS AND DOMESTIC ANIMALS**:
    1. Change "Harmful if swallowed." to "Harmful if swallowed, inhaled, or absorbed through the skin."
    2. Change "...chewing gum or using tobacco." to "...chewing gum, using tobacco, or using the toilet."
    3. Add the following sentence: "Prolonged or frequently repeated skin contact may cause allergic reaction in some individuals."
  - c. In the **WARRANTY STATEMENT**, change "...label instructions, or under abnormal conditions, or under conditions not reasonable foreseeable to seller, and buyer assumes the risk of any such use." to "...label instructions or under conditions not reasonable foreseeable to seller, and, to the extent consistent with applicable law, buyer assumes the risk of any such use."
3. You must submit an amendment or notification to comply with the Pesticide Management and Disposal rule (Pesticide Registration Notice 2007-4) by August 17, 2010.
