The revised amended label referred to above, submitted February 3, 2010 in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable conditional on the fulfillment of the following requirements:

- 1. On page 3 of the label in the **Terrestrial food/feed crops** table change "Welch Onion" to "Welsh Onion"
- 2. On page 3 of the label in the Terrestrial food/feed crops table delete "Scallion"
- 3. Submit or cite one additional field trial for mustard greens conducted in Zone 3. Submission due by December 2011.

One copy of the label stamped "Accepted with comments" is enclosed for your records. Please submit one copy of the final printed label that incorporates the required changes before the product is released for shipment.
