Dear Ms Wagner:

The revised amended label referred to above, submitted February 3, 2010 in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable conditional on the fulfillment of the following requirements:

1. On page 3 of the label in the **Terrestrial food/feed crops** table change "Welch Onion" to "Welsh Onion"
2. On page 3 of the label in the **Terrestrial food/feed crops** table delete "Scallion"
3. Submit or cite one additional field trial for mustard greens conducted in Zone 3. Submission due by December 2011.

One copy of the label stamped "Accepted with comments" is enclosed for your records. Please submit one copy of the final printed label that incorporates the required changes before the product is released for shipment.

Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities.

GENERAL DIRECTIONS FOR USE:

This product is intended only for the formulation of other Tebuconazole fungicide products. Products formulated using Tebuconazole Technical will require registration with the U.S. Environmental Protection Agency. Labeling for products formulated from this product must conform to that which is currently registered with the U.S. Environmental Protection Agency. Any variance from federally registered labeling for products containing tebuconazole will have to be supported by data provided by the formulator.

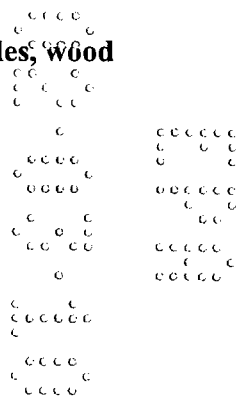
