Imidacloprid Technical is intended for formulation into end use products for:

**Terrestrial Non-food Crop or Residential and Commercial Outdoor:** Lawns, turf grasses, ornamentals, Christmas Trees, Poplar/cottonwood trees; above and below ground protection of wood, wood composites, plastics, cables, textiles, geotextiles, and termiticidal wall treatment, from insecticidal infestation. Darkling beetle and Hide beetle control in and around poultry facilities.

**Terrestrial Food Crops:** Bananas and Plantains, Bushberry Crop Subgroup, Brassica (Cole) Vegetable Crop Group, Bulb Vegetables Crop Group, Caneberry, Canola, Cereal Grain Crop Group (Barley, Oat, Rye, Sorghum, wheat (excluding rice)), Citrus Crop Group (containerized and field), Coffee, Cotton, Cranberry, Cucurbit Vegetable Crop Group, Fruiting Vegetables Crop Group, Globe Artichoke, Grapes, Greenhouse Vegetables, Herb Crop Group, Hops, Leafy Petiole Vegetables Crop Subgroup, Leafy Vegetables Crop Subgroup, Legume Vegetables Crop Group (except soybean), Peanuts, Pome Fruit Crop Group, Pomegranate, Potatoes (including seed piece treatment), Root and Tuber Vegetables Crop Group (except sugarbeet), Soybeans, Strawberry, Stone Fruit Crop Group, Sugarbeets, Tobacco, Tree Nut Crop Group (excluding almonds), and Tropical Fruit Crop Group.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal.

**Pesticide Storage:** Store in a cool dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food, and feed. Store in original container and out of the reach of children, preferably in a locked storage area.

Handle and open container in a manner as to prevent spillage. If the container is leaking or material is spilled for any reason or cause, carefully sweep material into a pile and dispose of as directed for pesticides below.
