- Seed treatment use in: alfalfa; barley; brassica leafy vegetables; bulb vegetables; corn; cotton; cucurbit vegetables; dried shelled peas and beans; edible podded legume vegetables; fruiting vegetables; leafy vegetables; leaves of root and tuber vegetables; oats; peanut; root vegetables; rye; sorghum; soybean; succulent shelled peas and beans; sugar beet; sunflower; tuberous and corm vegetables; wheat; triticale;
