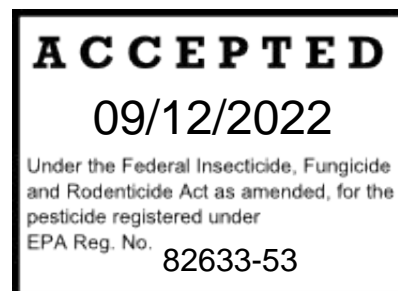

- **Terrestrial Non-Food Crops:** Conifer and Hardwood Nursery Seeds and Seedlings;
- **Seed Treatment Uses on:** Alfalfa, Barley, Buckwheat, Corn, Cotton, Dried Shelled Pea and Bean (except Soybean) Subgroup 6C, Millet (Pearl and Proso), Oats, Potato, Rice, Rye, Sorghum, Soybean, Sugar Beet, Triticale, and Wheat;
- Uses for which U.S. EPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration; and
- Uses for experimental purposes that are in compliance with U.S. EPA requirements.

STORAGE AND DISPOSAL
