 - Revise the EPA Registration Number to read, “EPA Reg. No. 82633-54.”
3. If, after formal consultation with the appropriate Service(s), additional modifications are identified in the Service’s Biological Opinion(s) for clothianidin, EPA will notify Sharda CropChem Ltd in writing consistent with the terms in the Biological Opinion of any necessary required changes. Sharda CropChem Ltd must submit an application for amendment incorporating any required changes, including amended labels, consistent with the timeline specified in EPA’s notification. If Sharda CropChem Ltd fails to comply with this term, Sharda CropChem Ltd has agreed in prior written acceptance on February 24, 2023 of these terms that EPA may cancel the registration under an expedited process under FIFRA 6(e).
4. Submit one copy of the final printed label for the record before you release the product for shipment.

Should you wish to add/retain a reference to the company’s website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. 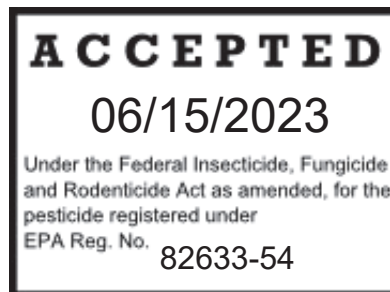
