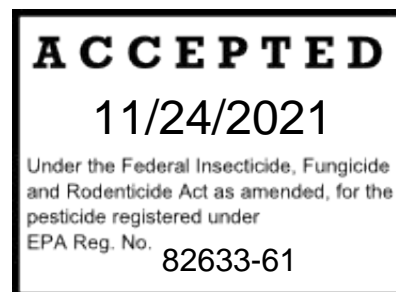

- **Aquatic Non-Food Uses on:** Bayous, Canals, Drainage Ditches, Lakes, Marshes, Non-irrigation Canals, Ponds, Reservoirs and other slow moving or quiescent bodies of water.
