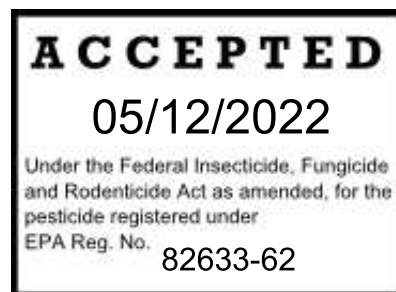

- **Greenhouse - Non-Food Crop:** Ornamental (shrubs, trees, flowers, and foliage plants) in greenhouses, shade houses, and nurseries;
