SELECTION OF TREATMENT AREAS: After removing as much food, water and harborage as possible, determine dry areas where rats and mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, beside burrows, in corners and concealed places, between floors and walls, or in locations where signs of rats or house mice have been seen. Protect bait from rain and snow.

APPLICATION DIRECTIONS:

Each RATIMOR WAX BLOCK weighs approximately 1.0 oz.

Norway Rats and Roof Rats: Apply 6 to 7 bait blocks per placement for controlling rats. Space placements 15 to 30 feet apart at appropriate locations within the infested area. Maintain a continuous supply of bait blocks for at least 10 days or until signs or

House Mice: Apply 1 to 2 bait blocks per placement, usually spaced 6 to 16 feet apart. Maintain a constant supply of bait blocks for 15 days or until signs of mouse activity cease.
