between areas to which this product is applied and surface water features such as ponds, streams, and springs will reduce the potential loading of thifensulfuron-methyl from runoff water and sediment. Runoff of this product will be greatly reduced by avoiding applications when rainfall or irrigation is expected to occur within 48 hours.

Non-Target Organism Advisory

This product is toxic to plants and may adversely impact the forage and habitat of non-target organisms, including pollinators, in areas adjacent to the treated area. Protect the forage and habitat of non-target organisms by minimizing spray drift. PRODUCT INFORMATION

This product is a dry flowable granule that is used for selective post-emergence weed control in wheat (including durum), barley, oat, triticale and fallow. The best control is obtained when this product is applied to young, actively growing weeds. The use rate will depend on weed spectrum and size of weed at time of application. The degree and duration of control may depend on the following:

- weed spectrum and infestation intensity
- weed size at application
- environmental conditions at and following treatment

This product is noncorrosive, nonflammable, nonvolatile, and does not freeze. This product should be mixed in water

and applied as a uniform broadcast spray.

PRECAUTIONS

- Prevent drift of spray to desirable plants. Take all necessary precautions to avoid all direct or indirect contact (such as spray drift) with non-target plants or areas.
- Carefully observe all sprayer cleanup instructions both prior to and after using this product, as spray tank residue may damage crops other than wheat, barley, triticale, oat or SU Tolerant Canola.
- Varieties of wheat (including durum), barley and triticale may differ in their response to various herbicides. Retam <u>Albaugh LLC</u> recommends that you first consult your state experiment station, university, or extension agent as to sensitivity to any herbicide. If no information is available, limit the initial use to a small area.
- Under certain conditions such as heavy rainfall, prolonged cold weather, or wide fluctuations in day/night temperatures prior to or soon after product application, temporary discoloration and/or crop injury may occur. To reduce the potential of crop injury, tank mix this product with 2,4-D (ester formulations perform best-see Tank Mixtures) and apply after the crop is in the tillering stage of growth.
- Dry, dusty field conditions may result in reduced control in wheel track areas.

RESTRICTIONS

- Do not use on any other crop other than wheat, barley, oat, triticale, fallow and SU Tolerant Canola.
- Do not apply, drain or flush equipment on or near desirable trees or other plants or on areas where their roots may extend, or in locations where the chemical may be washed or moved into contact with their roots.
- Do not use on lawns, walks, driveways, tennis courts, or similar areas.
- Do not be apply to wheat, barley, triticale or oat that is stressed by severe weather conditions, drought, low
 fertility, water-saturated soil, disease, or insect damage, as crop injury may result. Risk of injury is greatest when
 crop is in the 2- to 5-leaf stage.
- Do not apply when severe winter stress, drought, disease, or insect damage is evident.
- Do not apply to wheat, barley triticale or oat crops underseeded with another crop.
- Do not harvest sooner than 45 days after the last application of this product.

BIOLOGICAL ACTIVITY AND ENVIRONMENTAL CONDITIONS

This product is absorbed primarily through the foliage of plants, rapidly inhibiting the growth of susceptible weeds. 1 to 3 weeks after application to weeds (2 to 5 weeks for wild garlic), leaves of susceptible plants appear chlorotic, and the growing point subsequently dies.

This product provides the best control in vigorously growing crops that shade competitive weeds. Weed control in areas of thin crop stand or seeding skips may not be as satisfactory. However, a crop canopy that is too dense at application can intercept spray and reduce weed control.

The herbicidal action of this product may be affected in crops stressed from adverse environmental conditions (such as extreme temperatures or moisture), abnormal soil conditions, cultural practices, or variations in crop variety. In warm, moist conditions, the expression of herbicide symptoms is accelerated; in cold, dry conditions, expression of herbicide symptoms is delayed. In addition, weeds hardened-off by drought stress are less susceptible to this product.

WINDBLOWN SOIL PARTICLES

Rotam Thifen + Triben 750WG Herbicide has the potential to move off-site due to wind erosion. Soils that are subject to wind erosion usually have a high silt and/or fine to very fine sand fractions and low organic matter content. Other factors which can affects the movement of windblown soil include the intensity and direction of prevailing winds, vegetative cover, site slope, rainfall, and drainage patterns. Avoid applying Rotam Thifen + Triben 750WG Herbicide if prevailing local conditions may be expected to result in off-site movement.

SPRAY DRIFT MANAGEMENT

The interaction of many equipment and weather-related factors determines the potential for spray drift. The applicator is responsible for considering all these factors when making application decisions.

Aerial Applications:

• Do not release spray at a height greater than 10 ft. above the vegetative canopy, unless a greater application height is necessary for pilot safety.

- For applications prior to the emergence of crops and target weeds, applicators are required to use a Coarse or coarser droplet size (ASABE S572.1).
- For all other applications, applicators are required to use a Medium or coarser droplet size (ASABE S572.1).
- The boom length must not exceed 65% of the wingspan for airplanes or 75% of the rotor blade diameter for helicopters.
- Applicators must use ½ swath displacement upwind at the downwind edge of the field.
- Nozzles must be oriented so the spray is directed toward the back of the aircraft.
- Do not apply when wind speeds exceed 10 miles per hour at the application site.
- Do not apply during temperature inversions.

Ground Boom Applications:

- Apply with the nozzle height recommended by the manufacturer, but no more than 3 feet above the ground or crop canopy unless making a turf, pasture, or rangeland application, in which case applicators may apply with a nozzle height no more than 4 feet above the ground.
- For applications prior to the emergence of crops and target weeds, applicators are required to use a Coarse or coarser droplet size (ASABE S572.1).
- For all other applications, applicators are required to use a Medium or coarser droplet size (ASABE S572.1).
- Do not apply when wind speeds exceed 10 miles per hour at the application site.
- Do not apply during temperature inversions.

SPRAY DRIFT ADVISORIES

THE APPLICATOR IS RESPONSIBLE FOR AVOIDING OFF-SITE SPRAY DRIFT. BE AWARE OF NEARBY NON-TARGET SITES AND ENVIRONMENTAL CONDITIONS.

IMPORTANCE OF DROPLET SIZE

- Controlling Droplet Size Ground Boom
- Volume Increasing the spray volume so that larger droplets are produced will reduce spray drift. Use the highest
 practical spray volume for the application. If a greater spray volume is needed, consider using a nozzle with a
 higher flow rate.
- Pressure Use the lowest spray pressure recommended for the nozzle to produce the target spray volume and droplet size.
- Spray Nozzle Use a spray nozzle that is designed for the intended application. Consider using nozzles designed to reduce drift.

Controlling Droplet Size – Aircraft

• Adjust Nozzles - Follow nozzle manufacturers recommendations for setting up nozzles. Generally, to reduce fine droplets, nozzles should be oriented parallel with the airflow in flight.

BOOM HEIGHT – Ground Boom

Use the lowest boom height that is compatible with the spray nozzles that will provide uniform coverage. For ground equipment, the boom should remain level with the crop and have minimal bounce.

RELEASE HEIGHT - Aircraft

Higher release heights increase the potential for spray drift. When applying aerially to crops, do not release spray at a height greater than 10 ft. above the crop canopy, unless a greater application height is necessary for pilot safety.

SHIELDED SPRAYERS

Shielding the boom or individual nozzles can reduce spray drift. Consider using shielded sprayers. Verify that the shields are not interfering with the uniform deposition of the spray on the target area.

TEMPERATURE AND HUMIDITY

When making applications in hot and dry conditions, use larger droplets to reduce effects of evaporation.

TEMPERATURE INVERSIONS

Drift potential is high during a temperature inversion. Temperature inversions are characterized by increasing temperature with altitude and are common on nights with limited cloud cover and light to no wind. The presence of an

inversion can be indicated by ground fog or by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing. Avoid applications during temperature inversions.

WIND

Drift potential generally increases with wind speed. AVOID APPLICATIONS DURING GUSTY WIND CONDITIONS. Applicators need to be familiar with local wind patterns and terrain that could affect spray drift.

AIR ASSISTED (AIR BLAST) FIELD CROP SPRAYERS

Air assisted field crop sprayers carry droplets to the target via a downward directed air stream. Some may reduce the potential for drift, but if a sprayer is unsuitable for the application and/or set up improperly, high drift potential can result. It is the responsibility of the applicator to determine that a sprayer is suitable for the intended application, is configured properly, and that drift is not occurring.

Note: Air assisted field sprayers can affect product performance by affecting spray coverage and canopy penetration. Consult the spray equipment section of this label to determine if use of an air assist sprayer is recommended.

WEED RESISTANCE MANAGEMENT

Rotam Thifen + Triben 750WG Herbicide contains two active ingredients with the same mode of action. Thifensulfuronmethyl and tribenuron-methyl are classified as a Group 2 herbicide - an Acetolactate Synthase (ALS) or Acetohydroxy Acid Synthase (AHAS) inhibitor.

Herbicide resistance is defined as the inherited ability of a plant to survive and reproduce following exposure to a dose of herbicide normally lethal to the wild type. In a plant, resistance may be naturally occurring or induced by such techniques as genetic engineering or selection of variants produced by tissue culture or mutagenesis. Any weed population may contain or develop plants that are naturally resistant to Rotam Thifen + Triben 750WG Herbicide and other Group 2 herbicides. Weed species with acquired resistance to Group 2 herbicides may eventually dominate the weed population if Group 2 herbicides are used repeatedly in the same field or in successive years as the primary method of control for targeted species. This may result in partial or total loss of control of those species by Rotam Thifen + Triben 750WG Herbicide or other Group 2 herbicides.

Indicators of possible herbicide resistance include: (1) failure to control a weed species normally controlled by the herbicide at the dose applied, especially if control is achieved on adjacent weeds; (2) a spreading patch of noncontrolled plants of a particular weed species; (3) surviving plants mixed with controlled individuals of the same species. If resistance is suspected, prevent weed seed production in the affected area by an alternative herbicide from a different group or by a mechanical method such as hoeing or tillage. Prevent movement of resistant weed seeds to other fields by cleaning harvesting and tillage equipment when moving between fields, and planting clean seed. If a weed pest population continues to progress after treatment with this product, discontinue use of this product, and switch to another management strategy or herbicide with a different mode of action, if available.

To delay herbicide resistance, consider:

I

- Avoiding the consecutive use of Rotam Thifen + Triben 750WG Herbicide or other target site of action Group 2 herbicides that have a similar target site of action, on the same weed species.
- Using tank mixtures or premixes with herbicides from different target site of action Groups as long as the involved products are all registered for the same use, have different sites of action, and are both effective at the tank mix or prepack rate on the weed(s) of concern.
- Basing herbicide use on a comprehensive Integrated Pest Management (IPM) program.
- Monitoring treated weed populations for loss of field efficacy.
- Users should scout before and after application. Users should report lack of performance to registrant or their representative.

Contact your local extension specialist, certified crop advisors, and/or manufacturer for herbicide resistance management and/or integrated weed management recommendations for specific crops and resistant weed biotypes.

INTEGRATED PEST MANAGEMENT

This product may be used as part of an Integrated Pest Management (IPM) program that can include biological, cultural, and

genetic practices aimed at preventing economic pest damage. IPM principles and practices include field scouting or other detection methods, correct target pest identification, population monitoring, and treating when target pest populations reach locally determined action thresholds. Consult your state cooperative extension service, professional consultants or other qualified authorities to determine appropriate action treatment threshold levels for treating specific pest/crop systems in your area.

FALLOW

APPLICATION TIMING IN FALLOW

Apply this product as a fallow treatment, in the spring or fall when the majority of weeds have emerged and are actively growing.

USE RATES IN FALLOW

Apply this product at 0.3 oz. per acre (0.0047 lbs. a.i. tribenuron-methyl/acre and 0.0094 lbs a.i. thifensulfuronmethyl/acre) to 0.6 oz. per acre (0.0094 lbs. a.i. tribenuron-methyl/acre and 0.0188 lbs a.i. thifensulfuron-methyl/acre) to fallow. For control in oat, use 0.4 oz. of this product per acre (0.0063 lbs. a.i. tribenuron-methyl/acre and 0.0125 lbs a.i. thifensulfuron-methyl/acre) plus 2,4-D or MCPA (refer to TANK MIXTURES).
