Product Information

DICAMBA 700 SG is formulated as water dispersible granules for use as a spray to control and suppress many annual, biennial, and perennial broadleaf weeds, as well as woody brush and vines listed in **Table 1**. **DICAMBA 700 SG** can be used to control weeds in asparagus, corn, cotton, conservation reserve programs, fallow cropland, grass grown for seed, hay, proso millet, pasture, rangeland, farmstead (noncropland), small grains, sorghum, sugarcane, and turf.

Mode of Action

DICAMBA 700 SG is absorbed by plants through shoot and root uptake, and translocates throughout the plant's system and accumulates in areas of active growth. **DICAMBA 700 SG** interferes with the plant's growth hormones (auxins) resulting in death of many broadleaf weeds.

Resistance Management

Although **DICAMBA 700 SG** has a low probability of selecting for resistant weed biotypes, tank mix and rotate with herbicides possessing other modes of action to avoid weed resistance.

DICAMBA 700 SG is a water dispersible formulation that is applied using water or sprayable fluid fertilizer as the carrier. If a fluid fertilizer is to be used, conduct a compatibility test (see **COMPATIBILITY TEST**) prior to tank mixing.

Cleaning Spray Equipment

Clean application equipment thoroughly by using a strong detergent or commercial sprayer cleaner, according to the manufacturer's directions, and then triple rinsing the equipment before and after applying this product.

PROCEDURE FOR CLEANING SPRAY EQUIPMENT

Follow the steps listed below to thoroughly clean spray equipment following applications of DICAMBA 700 SG or tank mixes of DICAMDA 700 SG:

Application Instructions

Apply **DICAMBA 700 SG** to actively growing weeds as aerial, broadcast, band, or spot spray applications using water or sprayable fertilizer as a carrier. For **DICAMBA 700 SG** application rates for control or suppression by weed type and growth stage see **Table 2**. For crop specific application timing and other details, refer to **Crop specific Information**. To avoid uneven spray coverage, **do not** apply **DICAMBA 700 SG** during periods of gusty wind or when winds exceed 15 mph. Avoid off-target movement. Use extreme care when applying **DICAMBA 700 SG** to prevent injury to desirable plants and shrubs.

DO NOT treat areas where either possible downward movement into the soil or surface washing may cause contact of **DICAMBA 700 SG** with the roots of desirable plants such as trees and shrubs.

To avoid injury to desirable plants, thoroughly clean application equipment used to apply **DICAMBA 700 SG** (see **PROCEDURE FOR CLEANING SPRAY EQUIPMENT**) before reusing to apply any other chemicals.

All crop uses of **DICAMBA 700 SG** are intended for a normal growing interval between planting and harvest. No crop rotation restrictions exist if normal harvest of treated crop has occurred. If this interval is shortened, such as in cover crops that will be plowed under, **DO NOT** follow up with the planting of a sensitive crop.

Crops growing under stress conditions such as drought, poor fertility, or foliar damage due to hail, wind or insects, can exhibit various injury symptoms that may be more pronounced if herbicides are applied.

Consult your local or state authorities for possible application restrictions and advice concerning these and other special local use situations. Tank mix directions are for use only in states where the tank mix product and application site are registered.

Cultivation

DO NOT cultivate within 7 days after applying **DICAMDA 700 SG**.

Sensitive Crop Precautions

DICAMBA 700 SG can injure desirable trees and plants, particularly beans, cotton, flowers, fruit trees, grapes, ornamentals, peas, potatoes, soybeans, sunflowers, tobacco, tomatoes, and other broadleaf plants when in contact their roots, stems, or foliage. These plants are most sensitive to **DICAMBA 700 SG** during their development or growing stage.

Directions to avoid herbicide drift:

- **Do not** make applications when spray particles can be carried by air currents to areas where sensitive crops and plants are growing. **DO NOT** spray near sensitive plants if wind is gusty or exceeds 5 mph and moving in the direction of adjacent sensitive crops. Leave an adequate buffer zone between area to be treated and sensitive plants. Coarse sprays are less likely to drift out of the target area than fine sprays.
- Use coarse sprays (volume median diameter of 400 microns or more) to avoid potential herbicide drift. Select nozzles that are designed to produce minimal amounts of fine spray particles (less than 200 microns). Examples of nozzles designed to produce coarse sprays

via ground applications are **Delavan® Raindrops**, **Spraying Systems XR (excluding 110° tips) flat fans**, **Turbo Teejets®**, **Turbo Floodjets®**, or large capacity flood nozzles such as D10, TK10, or greater capacity tips.

- Keep the spray pressure at or below 20 psi and the spray volume at or above 20 gallons per acre (for ground broadcast applications), unless otherwise required by the manufacturer of drift-reducing nozzles. Consult your spray nozzle supplier concerning the choice of drift reducing nozzles.
- DO NOT apply DICAMBA 700 SG adjacent to sensitive crops when the temperature on the day of application is expected to exceed 85° F as drift is more likely to occur.
- · Agriculturally approved drift-reducing additives may be used.

Aerial Application Methods and Equipment

Water Volume: Use 1 to 10 gallons of water per acre (2 to 20 gallons of diluted spray per treated acre for preharvest uses). Use the higher spray volume with the specified rate range when treating dense or tall vegetation.

Application Equipment: Select nozzles designed to produce minimal amounts of fine spray particles. Make aerial applications at the lowest safe height to reduce exposing the spray to evaporation and wind. The applicator must follow the most restrictive use cautions to avoid drift hazards, including those found in this labeling, as well as state and local regulations and ordinances. DO NOT use aerial equipment if spray particles can be carried by the wind into areas where sensitive crops or plants are growing or when temperature inversions exist.

Ground Application (Banding)

When applying **DICAMBA 700 SG** by banding, determine the amount of herbicide and water volume needed using the following formula:

Ground Application (Broadcast)

Water Volume: Use 3 to 50 gallons of spray solution per broadcast acre for optimal performance. Use the higher spray volume within the specified rate range when treating dense or tall vegetation.

Application Equipment: Select nozzles designed to produce minimal amounts of fine spray particles. Spray with nozzles as close to the weeds as is practical for good weed coverage.

Apply **DICAMBA 700 SG** through wiper application equipment to control or suppress actively growing broadleaf weeds, brush, and vines. Use a solution containing 90 ounces **DICAMBA 700 SG** per 1 gallon water. **DO NOT** contact desirable vegetation with herbicide solution. Wiper applications can be made to crops (including pastures) and non-cropland areas described in this label with the exception of cotton, sorghum, and soybean.

Additives

with precipitation in reduced volumes. Use AMS only if it has been demonstrated to be successful in local experience.

Nonionic Surfactant

Use 1 pint of an 80% active nonionic spray surfactant per 100 gallons of water. A higher spray surfactant rate within the specified rate range may be required to control certain weeds.

Oil Concentrate

A crop oil concentrate must contain either a petroleum or vegetable oil base and must meet all of the following criteria:

- be nonphytotoxic,
- contain only EPA-exempt ingredients,
- provide good mixing quality in the jar test, and
- be successful in local experience.

The exact composition of suitable products will vary; however, vegetable and petroleum oil concentrates should contain emulsifiers to provide good mixing quality. Highly refined vegetable oils have proven more satisfactory than unrefined vegetable oils.

Adjuvants-containing-crop-oil-concentrates-may-be-used-in-preplant,-preemergence, andpreharvest application, as well as in pastures and noncropland. **DO NOT** use crop oil concentrate for postemergence in-crop applications unless specifically allowed in **Crop-specific Information** section of this label.

Compatibility Test for Mix Components

Before mixing components, always perform a compatibility jar test. For 20 gallons per acre spray volume, use 3.3 cups (800 mL) of water. For other spray volumes, adjust accordingly. Only use water from the intended source at the source temperature.

Add components in the sequence indicated in the **Mixing Order** using 2 teaspoons for each pound or 1 teaspoon for each pint of label rate per acre.

Always cap the jar and invert 10 cycles between component additions.

When the components have all been added to the jar, let the solution stand for 15 minutes. Evaluate the solution for uniformity and stability. The spray solution should not have free oil on the surface, nor fine particles that precipitate to the bottom, nor thick (clabbered) texture. If the spray solution is not compatible, repeat the compatibility test with the addition of a suitable compatibility agent. If the solution is then compatible, use the compatibility agent as directed on its label. If the solution is still incompatible, **DO NOT** mix the ingredients in the same tank.

Mixing Order

- 1. Water. Begin by agitating a thoroughly clean sprayer tank three-quarters full of clean water.
- 2. Agitation. Maintain constant agitation throughout mixing and application.
- 3. Inductor. If an inductor is used, rinse it thoroughly after each component has been added.
- 4. **Products in PVA bags.** Place any product contained in water-soluble PVA bags into the mixing tank. Wait until all water-soluble PVA bags have fully dissolved and the product is evenly mixed in the spray tank before continuing.
- 5. **Water-dispersible products** (dry flowables, wettable powders, suspension concentrates, or suspo emulsions).
- 6. Water-soluble products (such as DICAMBA 700 SG)
- 7. Emulsifiable concentrates (such as oil concentrate when applicable).
- 8. Water-soluble additives (such as AMS or UAN when applicable).
- 9. Remaining quantity of water. Maintain constant agitation during application.

Tank Mix Partners/Components

The herbicide products listed can be applied with **DICAMBA 700 SG** according to the specific tank mixing instructions in this label and respective product labels. **DICAMBA 700 SG** can also be tank mixed with other suitable registered herbicides.

See section **Crop-specific Information** for more details. Read and follow the applicable **Restrictions and Limitations and Directions For Use** on all products involved in tank mixing. The most restrictive labeling applies to tank mixes. **DICAMBA 700 SG** can also be used in tank mixtures with foliar applied insecticides including synthetic pyrethroids such as **Ambush®**, **Asana®**, **Pounce®** and **Warrior®** or with the carbamate insecticide **Furadan®**. **DO NOT** apply **DICAMBA 700 SG** in tank mixtures with **Lorsban®** insecticide.

Physical incompatibility, reduced weed control, or crop injury can result from mixing **DICAMBA 700 SG** with other pesticides (fungicides, herbicides, insecticides, or miticides), additives, or fertilizers. Rotam does not recommend using tank mixes other than those specifically listed on the product labeling. Local agricultural authorities may be a source of information when using tank mixes other than those recommended by Rotam.

Restrictions and Limitations

- Maximum seasonal use rate: Refer to table for crop specific maximum seasonal use rates.
- DO NOT exceed 48 ounces of DICAMBA 700 SG (2 lbs. acid equivalent) per acre, per year.
- Preharvest Interval (PHI): Refer to Crop-specific Information for preharvest intervals.
- Restricted-Entry Interval (REI): 24 hours

Crop Rotational Restrictions

The interval between application and planting rotational crop is given below. Always exclude counting days when the ground is frozen. Planting at intervals less than specified below may result in crop injury. Moisture is essential for the degradation of this herbicide in soil. If dry weather prevails, use cultivation to allow herbicide contact with moist soil.

- Planting/replanting restrictions for DICAMBA 700 SG applications of 17 ounces per acre or less. No rotational cropping restrictions apply at 120 days or more following application. Additionally, for annual crop uses in this label including corn, cotton, sorghum, and soybean, follow the preplant use directions in Crop-specific Information. For barley, oat, wheat, and other grass seedlings, the interval between application and planting is 15 days per 6 ounces per acre applied east of the Mississippi River and 22 days per 6 ounces per acre west of the Mississippi River.
- Planting/replanting restrictions for applications of more than 17 ounces and up to 48 ounces of DICAMBA 700 SG per acre. Corn, sorghum, cotton (east of the Rocky Mountains) and all other crops grown in areas with 30" or more of annual rainfall may be planted 120 days or more after application. Barley, oat, wheat, and other grass seedings, may be planted if the interval from application to planting is 30 days per 12 ounces per acre east of the Mississippi River and 45 days per 12 ounces per acre west of the Mississippi River. For all other crops in areas with less than 30" of annual rainfall, the interval between application and planting is 180 days or more.
- **Rainfast period.** Rainfall or irrigation occurring within 4 hours after postemergence applications can reduce the effectiveness of **DICAMDA 700 SG**.
- Stress. DO NOT apply to crops under stress due to lack of moisture, hail damage, flooding, herbicide injury, mechanical injury, insects, or widely fluctuating temperatures as injury may result.

Crop-specific Information

Asparagus

Apply **DICAMBA 700 SG** to emerged and actively growing weeds in 40 to 60 gallons of diluted spray per treated acre immediately after cutting the field, but at least 24 hours before the next cutting. Multiple applications may be made per growing season.

If spray contacts emerged spears, crooking (twisting) of some spears may result. If such crooking occurs, discard affected spears.

Rates: Apply 6 to 12 ounces of **DICAMBA 700 SG** to control annual sowthistle, black mustard, Canada and Russian thistle, and redroot pigweed, (carelessweed). Apply 12 ounces of **DICAMBA 700 SG** to control common chickweed, field bindweed, nettleleaf goosefoot, and wild radish. Multiple applications may be made per growing season; however, **DO NOT** exceed a total of 12 ounces of **DICAMBA 700 SG** per treated acre, per crop year.

DO NOT harvest prior to 24 hours after treatment. **DO NOT** use in the Coachella Valley of California.

Asparagus Tank Mixes

Apply 6 to 12 ounces of **DICAMBA 700 SG** with glyphosate or 2,4-D to improve control of Canada thistle and field bindweed.

Between-crop Applications

PREPLANT DIRECTIONS (POSTHARVEST, FALLOW, CROP STUBBLE, SET-ASIDE) FOR BROADLEAF WEED CONTROL

Apply **DICAMBA 700 SG** either postharvest in the fall, spring, or summer during the fallow period or to crop stubble/set-aside acres. Apply **DICAMBA 700 SG** as a broadcast or spot treatment to emerged and actively growing weeds after crop harvest (postharvest) and before a killing frost or in the fallow cropland or crop stubble the following spring or summer.

See **Crop Rotational Restrictions** in the **Restrictions and Limitations** section for the required interval between application and planting to prevent crop injury.

Rates and Timings

Apply 3 to 24 ounces of **DICAMBA 700 SG** per acre. Refer to **Table 2** to determine use rates for specific targeted weed species. Apply **DICAMBA 700 SG** when annual weeds are less than 6" tall, when biennial weeds are in the rosette stage, and to perennial weed regrowth in late summer or fall following a mowing or tillage treatment. The most effective control of upright perennial broadleaf weeds such as Canada thistle and Jerusalem artichoke occurs if **DICAMBA 700 SG** is applied when the majority of weeds have at least 4" to 6" of regrowth or for weeds such as field bindweed and hedge bindweed that are in or beyond the full bloom stage.

Avoid disturbing treated areas following application. Treatments may not kill weeds that develop from seed or underground plant parts such as rhizomes or bulblets, after the effective period for **DICAMDA 700 SG**. For seedling control, a follow-up program or other cultural practices could be instituted. For small grain in-crop uses of **DICAMDA 700 SG**, refer to the small grain section for details.

Between-crop Tank Mixes

In tank mixes with other suitable registered herbicides, including one or more of the following herbicides, apply 3 to 12 ounces of **DICAMBA 700 SG** per acre to control annual weeds, or 12 to 24 ounces of **DICAMBA 700 SG** per acre to control biennial and perennial weeds.

Corn (Field, Pop, Seed, and Silage)

Do not allow direct contact of **DICAMBA 700 SG** with corn seed. If corn seeds are less than 1.5" below the soil surface, delay application until corn has emerged.

Applications of **DICAMBA 700 SG** to corn during periods of rapid growth can result in temporary leaning. Corn will usually become erect within 3- to 7-days. Delay cultivation until after corn is growing normally to avoid breakage.

Corn may be harvested or grazed for feed once the crop has reached the ensilage (milk) stage or later in maturity.

Up to 2 applications of **DICAMBA 700 SG** may be made during a growing season. Sequential applications must be separated by 2 weeks or more. **DO NOT** exceed a total of 17 ounces of **DICAMBA 700 SG** per acre per crop year.

DO NOT apply **DICAMBA 700 SG** to seed corn or popcorn without first verifying with your local seed corn company (supplier) the selectivity of **DICAMBA 700 SG** on your inbred line or variety of popcorn to avoid potential injury of sensitive varieties.

Avoid using crop oil concentrates after crop emergence to avoid crop injury. Use of crop oil concentrates only in dry conditions when corn is less than 5" tall and when applying **DICAMBA 700 SG** alone or tank mixed with atrazine.

Do not use a sprayable fluid fertilizer as the carrier for applications of **DICAMBA 700 SG** made after corn emergence.

DICAMBA 700 SG is not registered for use on sweet corn.

PREPLANT AND PREEMERGENCE APPLICATION IN NO TILLAGE CORN

Rates: Apply 12 ounces of **DICAMBA 700 SG** per acre on medium- or fine-textured soils containing 2.5% or greater organic matter. Use 6 ounces of **DICAMBA 700 SG** per acre on coarse soils (sand, loamy sand, and sandy loam) or medium- and fine-textured soils with less than 2.5% organic matter.

Timing: Apply **DICAMBA 700 SG** to emerged weeds before, during, or after planting a corn crop. When planting into a legume sod (e.g. alfalfa or clover), apply **DICAMBA 700 SG** after 4" to 6" of regrowth has occurred.

PREEMERGENCE APPLICATION IN CONVENTIONALOR REDUCED TILLAGE CORN Rates: Apply 12 ounces of **DICAMBA 700 SG** per treated acre to medium- or fine-textured soils that contain 2.5% organic matter or more. **DO NOT** apply to coarse-textured soils (sand, loamy sand, or sandy loam) or any soil with less than 2.5% organic matter until after corn emergence (see **Early Postemergence** uses below).

Timing: Apply **DICAMBA 700 SG** after planting and prior to corn emergence. Preemergence application of **DICAMBA 700 SG** does not require mechanical incorporation to become active. Make a shallow mechanical incorporation if the application is not followed by adequate rainfall or sprinkler irrigation. Avoid tillage equipment (e.g. drags, harrows) that concentrates treated

soil over seed furrow, as seed damage could result. Preemergence control of cocklebur, jimsonweed, and velvetleaf may be reduced if conditions such as low temperature or lack of soil moisture cause delayed or deep germination of weeds.

EARLY POSTEMERGENCE APPLICATION IN ALL TILLAGE SYSTEMS

Rates: Apply 12 ounces of **DICAMBA 700 SG** per treated acre. Reduce the rate to 6 ounces of **DICAMBA 700 SG** per treated acre for corn grown on coarse-textured soils (sand, loamy sand, and sandy loam).

Timing: Apply between corn emergence and the 5-leaf stage or 8" tall, whichever occurs first. Refer to **Late Postemergence Application** if the sixth true leaf is emerging from whorl or the corn is greater than 8" tall.

LATE POSTEMERGENCE APPLICATION

Rate: Apply 6 ounces of DICAMBA 700 SG per treated acre.

Timing: Apply **DICAMBA 700 SG** from 8" to 36" tall corn or 15 days before tassel emergence, whichever comes first. Apply when weeds are less than 3" tall. Apply directed spray when corn leaves prevent proper spray coverage, sensitive crops are growing nearby, or tank mixing with 2,4-D.

DO NOT apply DICAMBA 700 SG when soybeans are growing nearby if any of these - conditions exist:

- corn is more than 24" tall
- · soybeans are more than 10" tall
- soybeans have begun to bloom

When using tank mix or sequential applications with **DICAMDA 700 SG**, always follow the companion product label to determine specific use rates by soil types, weed species, and weed or crop growth stage. In addition, follow precautions and restrictions including state and local use restrictions that may apply to specific products.

Cotton

PREPLANT APPLICATION

Apply up to 6 ounces of **DICAMBA 700 SG** per acre to control emerged broadleaf weeds prior to planting cotton in conventional or conservation tillage systems. Apply **DICAMBA 700 SG** when weeds are in the 2 to 4 leaf stage and rosettes are less than 2" across.

Following application of **DICAMBA 700 SG** and a minimum accumulation of 1" of rainfall or overhead irrigation, a waiting interval of 21 days is required per 6 ounces per acre or less. These intervals must be observed prior to planting cotton.

DO NOT apply preplant to cotton west of the Rockies. **DO NOT** make **DICAMBA 700 SG** preplant applications to cotton in geographic areas with average annual rainfall less than 25". If applying a spring preplant treatment following application of a fall preplant (postharvest) treatment, then the combination of both treatments must not exceed 48 ounces per acre.

Cotton Tank Mixes

For control of grasses or additional broadleaf weeds, **DICAMBA 700 SG** can be tank mixed with **Bladex®**, **Caparol®**, **Gramoxone® Extra**, and **Roundup Ultra® RT herbicides**.

Grass Grown for Seed

Apply 6 to 12 ounces of **DICAMBA 700 SG** per treated acre on seedling grass after the crop reaches the 3 to 5 leaf stage. Apply up to 24 ounces of **DICAMBA 700 SG** on well-established perennial grass. Apply **DICAMBA 700 SG** when weeds are in the 2 to 4 leaf stage and rosettes are less than 2" across. Use the higher level within the specified rate range when treating more mature weeds or dense vegetative growth.

To suppress annual grasses such as brome (downy and ripgut), rattail fescue, and windgrass, apply up to 24 ounces of **DICAMBA 700 SG** per treated acre in the fall or late summer after harvest and burning of established grass seed crops. Make applications immediately following the first irrigation when the soil is moist and before weeds have more than 2 leaves.

DO NOT apply **DICAMBA 700 SG** after the grass seed crop begins to joint. Refer to the **Pasture, Hay, Rangeland, and Farmstead** section for grazing and feeding restrictions.

Proso Millet

For use only within Colorado, Nebraska, North Dakota, South Dakota, and Wyoming.

DICAMBA 700 SG combined with 2,4-D will provide control or suppression of the annual broadleaf weeds listed in **Table 1**.

Apply 3 ounces of **DICAMBA 700 SG** with 0.375 pounds ai of 2,4-D. Apply the tank mix of **Clarity® herbicide** + 2,4-D as a broadcast or spot treatment to emerged and actively growing weeds and when proso millet is in the 2 to 5 leaf stage. Use directions for 2,4-D products vary with manufacturers. Refer to a 2,4-D product with labeling consistent with the crop stage timing for **Clarity®**. Some types of proso millet may be affected adversely by a tank mix of **Clarity®** + 2,4-D.

DO NOT apply unless possible proso millet crop injury will be acceptable.

Restrictions for proso millet that is grazed or cut for hay are indicated in **Table 6**. See **Timing Restrictions for Lactating Dairy Animals Following Treatment in Pasture, Hay, Rangeland, and Farmstead** section of this label.

Pasture, Hay, Rangeland, and Farmstead (noncropland)

Apply **DICAMBA 700 SG** on pasture, hay, rangeland, and farmstead (non-cropland) (including fencerows and non-irrigation ditchbanks) to control or suppress broadleaf weed and brush species listed in **Table 1**.

Apply **DICAMBA 700 SG** to non-cropland areas to control broadleaf weeds in noxious weed control programs, districts, or areas including broadcast or spot treatment of roadsides and highways, utilities, railroad, and pipeline rights-of-way. Noxious weeds must be recognized at the state level, but programs may be administered at state, county, or other level.

DICAMBA 700 SG uses described in this section also pertain to small grains (forage sorghum, rye, sudangrass, or wheat) grown for pasture use only. Some perennial weeds may be controlled with lower rates of either **DICAMBA 700 SG** or **DICAMBA 700 SG** plus 2,4-D (refer to **Table 2.**).

Rates and Timings

Refer to **Table 2** for rate selection based on targeted weed or brush species. Some weed species will require tank mixes for adequate control.

DO NOT broadcast apply more than 24 ounces per acre. Retreatments may be made as needed; however, **DO NOT** exceed a total of 24 ounces of **DICAMBA 700 SG** per treated acre during a growing season.

Crop-specific Restrictions and Limitations

DO NOT apply more than 12 ounces of DICAMBA 700 SG per acre to small grains grown for pasture. Do not apply more than 12 ounces of **DICAMBA 700 SG** to newly seeded areas or crop injury can occur.

Dicamba 700 SG Application for EPA Registration

Established grass crops growing under stress can exhibit various injury symptoms that may be more pronounced if herbicides are applied. Bentgrass, carpetgrass, buffalograss, and St. Augustinegrass may be injured if more than 12 ounces of **DICAMBA 700 SG** is applied per acre. Usually colonial bentgrasses are more tolerant than creeping types. Velvetgrasses are most easily injured. Treatments will kill or injure alfalfa, clovers, lespedeza, wild winter peas, vetch, and other legumes.

There are no grazing restrictions for animals other than lactating dairy animals. **Table 6** lists the timing restrictions for grazing or harvesting hay from treated fields.

Apply **DICAMBA 700 SG** using water, oil in water emulsions including invert systems, or sprayable fluid fertilizer as a carrier (refer to **the Compatibility Test for Mix Components**).

To prepare oil in water emulsions, half-fill spray tank with water, then add the appropriate amount of emulsifier. With continuous agitation, slowly add the herbicide and then the oil (such as diesel oil or fuel oil) or a premix of oil plus additional emulsifier to spray tank. Complete filling of spray tank with water. Maintain vigorous agitation during spray operation to prevent oil and water from forming separate layers. **DICAMBA 700 SG** may be applied broadcast using either ground or aerial application equipment.

Aerial Application

• Spray Volume. Use 2 to 40 gallons of diluted spray per treated acre in a water-based carrier.

Ground Application

- **Spray Volume.** Use 3 to 600 gallons of diluted spray per treated acre. The volume of spray applied will depend on the height, density, and type of weeds or brush being treated and on the type of equipment being used.
- Spot Treatments. Apply DICAMBA 700 SG to individual clumps or small areas of undesirable vegetation using handgun or similar types of application equipment. Apply diluted sprays to allow complete wetting (up to runoff) of foliage and stems.

Cut Surface Treatments

Apply **DICAMBA 700 SG** as a cut surface treatment to control unwanted trees and prevent sprouts of cut trees.

Rate: Mix 30 to 90 ounces **DICAMBA 700 SG** with 1 gallon water to create the application solution. Use the lower dilution rate within the specified rate range when treating difficult-to-control species.

- For Frill or Girdle Treatments: Make a continuous cut or a series of overlapping cuts using an axe to girdle tree trunk. Spray or paint the cut surface with the solution.
- For Stump Treatments: Spray or paint freshly cut surface with the water mix. Wet the area adjacent to the bark thoroughly.

NOTE: For more rapid foliar effects, add 2,4-D to the solution.

Applications For Control of Dormant Multiflora Rose

Apply **DICAMBA 700 SG** when plants are dormant as a spot treatment to the soil or as a Lo-Oil basal bark treatment using an oil-water emulsion solution.

 Spot treatments. Make spot treatment applications of DICAMBA 700 SG directly to the soil as close as possible to the root crown but within 6" to 8" of the crown. On sloping terrain, apply DICAMBA 700 SG to the uphill side of the crown. DO NOT apply when snow or waterprevents applying DICAMBA 700 SG directly to the soil. The use rate of DICAMBA 700 SG depends on the canopy diameter of the multiflora rose.

Examples: Use 0.18, 0.72, or 1.7 ounces of **DICAMBA 700 SG** respectively, for 5, 10, or 15 feet canopy diameters.

 Lo-Oil basal bark treatments. For Lo-Oil basal bark treatments, apply DICAMBA 700 SG to the basal stem region from the ground line to a height of 12" to 18". Spray until runoff, with special emphasis on covering the root crown. Apply DICAMBA 700 SG when plants are dormant. DO NOT apply after bud break or when plants are showing signs of active growth. DO NOT apply when snow or water prevents applying DICAMBA 700 SG to the ground line.

To prepare approximately 2 gallons of a Lo-Oil spray solution:

- 1. Combine 1.5 gallons of water, 1 ounce of emulsifier, 12 ounces of **DICAMDA 700 SG**, and 2.5 pints of No. 2 diesel fuel.
- 2. Adjust the amounts of materials used proportionately to the amount of final spray solution desired.

DO NOT exceed 8 gallons of spray solution mix applied per acre, per year.

Conservation Reserve Program (CRP)

NEWLY SEEDED AREAS

Apply DICAMBA 700 SG either preplant or postemergence to newly seeded grasses or small grains such as barley, oats, rye, sudangrass, wheat, or other grain species grown as a cover crop. Make postemergence applications after seedling grasses exceed the 3-leaf stage. Rates of **DICAMBA 700 SG** greater than 12 ounces per treated acre can severely injure newly seeded grasses.

Preplant applications can injure new seedlings if the interval between application and grass planting is less than 45 days per 12 ounces of **DICAMBA 700 SG** applied per treated acre west of the Mississippi River or 20 days per 12 ounces applied east of the Mississippi River.

ESTABLISHED GRASS STANDS

Established grass stands are perennial grasses planted one or more seasons prior to treatment. Certain species (bentgrass, carpetgrass, smooth brome, buffalograss, or St. Augustine grass) can be injured when treated with more than 12 ounces of **DICAMBA 700 SG** per treated acre. When applied at specified rates, **DICAMBA 700 SG** will control many annual and biennial weeds and provide control or suppression of many perennial weeds.

Rates and Timings: Apply 3 to 24 ounces of **DICAMBA 700 SG** per acre. Refer to **Table 2** for rates based on target weed species. Tank mix or apply **DICAMBA 700 SG** sequentially with other products labeled for use in Conservation Reserve Programs such as atrazine, **Cyclone®**, glyphosate (**Acquire®**, **Roundup Ultra®**), **Gramoxone® Extra**, **Touchdown®**, or 2,4-D.

Retreatments may be made as needed; however, **DO NOT** exceed a total of 48 ounces of **DICAMBA 700 SG** per acre.

Small Grains: Not underseeded to legumes (fall- and spring-seeded barley, oat, triticale and wheat)

DICAMBA 700 SG combinations with listed tank mix partners will control or suppress the annual broadleaf weeds listed in **Table 1.** To improve control of listed weeds, tank mix **DICAMBA 700 SG** with one or more of the herbicides listed. **DICAMBA 700 SG** used in a tank mix with other herbicides offers the best spectrum of weed control and herbicide tolerant or resistant weed management. Refer to the specific section crop for **DICAMBA 700 SG** application rate and timing.

For applications prior to weed emergence or when sulfonylurea-resistant weeds are present or suspected, tank mix a minimum of 2 ounces of **DICAMBA 700 SG** per treated acre with a non-sulfonylurea herbicide such as 2,4-D or MCPA. Tank mixing **DICAMBA 700 SG** with these products will offer more consistent control of sulfonylurea-resistant weeds.

Additives: When tank mixing DICAMBA 700 SG with sulfonylurea herbicides (such as Ally®, Amber®, Canvas®, Express®, Finesse®, Glean®, Harmony® Extra, and Peak®), use 1 to 4 pints of an agriculturally approved surfactant (containing at least 80% active ingredient) per 100 gallons of spray or not more than 0.25 to 0.5% by volume. Use the highest rate of surfactant when using the lower rate ranges of the tank mix or when treating more mature and difficult to control weeds or dense vegetative growth.

Dicamba 700 SG Application for EPA Registration

Refer to the specific crop sections below for use rates. When treating difficult to control weeds such as kochia, wild buckwheat, cow cockle, prostrate knotweed, Russian thistle, and prickly lettuce or when dense vegetative growth occurs, use the 2 to 3 ounces of **DICAMBA 700 SG** per acre.

Timings: Apply **DICAMBA 700 SG** before, during, or after planting small grains. See specific small grain crop uses below for maximum crop stage. Apply **DICAMBA 700 SG** when weeds are in the 2 to 3 leaf stage and rosettes are less than 2" across. Applying **DICAMBA 700 SG** to small grains during periods of rapid growth can result in crop leaning. This condition is temporary and will not reduce crop yields.

Make applications to small grains by aerial application with 1 gallon of water or more per acre. Where dense foliage is present, use 2 to 3 gallons of water per acre.

Restrictions for small grain areas that are grazed or cut for hay are indicated in **Table 6.** in **Pasture, Hay, Rangeland, and Farmstead** section of this label.

Small Grains: Barley (fall- and spring-seeded)

EARLY SEASON APPLICATIONS

Apply 1.5 to 3 ounces of **DICAMBA 700 SG** to fall-seeded barley prior to the jointing stage. Apply 1.5 to 2 ounces of **DICAMBA 700 SG** before spring-seeded barley exceeds the 4-leaf stage.

NOTE: For spring barley varieties that are seeded during the winter months or later, follow the rates and timings given for spring-seeded barley.

DO NOT tank mix **DICAMBA 700 SG** with 2,4-D in early season applications on spring-seeded barley.

PREHARVEST APPLICATIONS

DICAMBA 700 SG controls weeds that may interfere with harvest of fall- and spring-seeded barley. Apply 6 ounces of **DICAMBA 700 SG** per acre as a broadcast or spot treatment to annual broadleaf weeds when barley is in the hard dough stage and the green color is gone from the nodes (joints) of the stem. Make application when weeds are actively growing, but before weeds canopy.

A waiting interval of 7 days is required before harvest.

DO NOT use preharvest-treated barley for seed unless a germination test is performed on the seed with an acceptable result of 95% germination or better.

For control of additional broadleaf weeds or grasses, tank mix **DICAMBA 700 SG** with other herbicides, such as 2,4-D, that are labeled for preharvest uses in barley.

DO NOT make preharvest applications in California.

Barley Tank Mixes

DICAMBA 700 SG can be applied in tank mixes with other suitable registered herbicides, including one or more of the following herbicides.

Small Grains: Oat (fall- and spring-seeded)

EARLY SEASON APPLICATIONS

Apply 1.5 to 3 ounces of **DICAMBA 700 SG** per acre to fall-seeded oat prior to the jointing stage. Apply 1.5 to 3 ounces of **DICAMBA 700 SG** before spring-seeded oat exceeds the 5-leaf stage.

Tank mix **DICAMBA 700 SG** with other suitable registered herbicides, such as MCPA amine or ester, for applications in oat.

DO NOT tank mix DICAMBA 700 SG with 2,4-D in oat.

Small Grains: Triticale (fall- and spring-seeded)

EARLY SEASON APPLICATIONS

Apply 1.5 to 3 ounces of **DICAMBA 700 SG** to triticale. Make early season applications to fallseeded triticale prior to the jointing stage.

Make early season applications to spring-seeded triticale before triticale reaches the 6-leaf stage.

Triticale Tank Mixes: Tank mix DICAMBA 700 SG in combination with bromoxynil (Buctril, Moxy[™] 2E) herbicide.

Small Grains: Wheat (fall- and spring-seeded)

EARLY SEASON APPLICATIONS

Apply 1.5 to 3 ounces of **DICAMBA 700 SG** to wheat unless using one of the fall-seeded wheat specific programs below. Make early season applications to fall-seeded wheat prior to the jointing stage. Make early season applications to spring-seeded wheat before wheat exceeds the 6-leaf stage. Make application to early developing wheat varieties such as TAM 107, Madison, or Wakefield between early tillering and the jointing stage. Make application prior to the jointing stage.

To improve control of Russian thistle, flixweed, gromwell, or mayweed, add 2,4-D amine or ester to a tank mix with other suitable registered herbicides such as one of the following herbicides: Ally®, Amber®, Canvas®, Express®, Finesse®, Glean®, Harmony® Extra, or Peak®.

SPECIFIC USE PROGRAMS FOR FALLSEEDED WHEAT ONLY

Apply **DICAMBA 700 SG** at 4 ounces on fall-seeded wheat in Western Oregon as a spring application only. In Colorado, Kansas, New Mexico, Oklahoma, and Texas, apply up to 6 ounces of **DICAMBA 700 SG** on fall-seeded wheat after it exceeds the 3-leaf stage for suppression of perennial weeds, such as field bindweed. Make applications in the fall following a frost but before a killing freeze. Tank mix **DICAMBA 700 SG** with 2,4-D amine at 6 ounces after wheat begins to tiller. Periods of extended stress such as cold and wet weather may enhance the possibility of crop injury. For fall applications only, **DO NOT** use if the potential for crop injury is not acceptable.

PREHARVEST APPLICATIONS

DICAMBA 700 SG controls weeds that may interfere with harvest of wheat. Apply 6 ounces **DICAMBA 700 SG** per acre as a broadcast or spot treatment to annual broadleaf weeds when wheat is in the hard dough stage and the green color is gone from the nodes (joints) of the stem. Make application when weeds are actively growing but before weeds canopy.

A waiting interval of 7 days is required before harvest.

DO NOT use preharvest-treated wheat for seed unless a germination test is performed on the seed with an acceptable result of 95% germination or better. For control of additional broadleaf weeds or grasses, tank mix **DICAMBA 700 SG** with other herbicides such as Ally®, Roundup Ultra®, and 2,4-D.

DO NOT make preharvest applications in California.

Wheat Tank Mixes

Apply **DICAMBA 700 SG** in tank mixes with other suitable registered herbicides, including one or more of the following herbicides:

¹ **DO NOT** use low rates of sulfonylurea herbicides, such as Ally, Amber, Canvas, Express, Finesse, Glean, Harmony Extra, and Peak on more mature weeds or on dense vegetative growth.

² **DO NOT** use Clarity as a tank mix treatment with Dakota or Tiller on Durum wheat. **DO NOT** tank mix with Tiller if wild oat is the target weed.

³ Tank mixes with Karmex and metribuzin are for use in fallseeded wheat only.

⁴ A tank mix of up to 3 ounces of **DICAMBA 700 SG** with Roundup Ultra® RT or any glyphosate formulation labeled for use as a preplant application to small grains may be applied with no waiting period prior to planting.

⁵ Up to 32 fluid ounces of (1 .0 pound a.e.) may be used on fallseeded wheat if crop injury is acceptable. When using formulations other than 4 pounds per gallon, use the pounds of a.e. per acre listed.

Sorghum

Apply DICAMBA 700 SG preplant, postemergence, or preharvest in sorghum to control many annual broadleaf weeds and to reduce competition from established perennial broadleaf weeds, as well as control their seedlings.

DO NOT graze or feed treated sorghum forage or silage prior to mature grain stage. If sorghum is grown for pasture or hay, refer to **Pasture, Hay, Rangeland, and Farmstead** section of this label for specific grazing and feeding restrictions.

DO NOT apply DICAMBA 700 SG to sorghum grown for seed production.

PREPLANT APPLICATION

Apply up to 6 ounces of **DICAMBA 700 SG** per acre if applied at least 15 days before sorghum planting.

POSTEMERGENCE APPLICATION

Apply up to 6 ounces of **DICAMBA 700 SG** after sorghum is in the spike stage (all sorghum emerged) but before sorghum is 15" tall. Apply **DICAMBA 700 SG** when the sorghum crop is in the 3 to 5 leaf stage and weeds are small (less than 3" tall). Use drop pipes (drop nozzles) if sorghum is taller than 8". Keep the spray off the sorghum leaves and out of the whorl to reduce the likelihood of crop injury and to improve spray coverage of weed foliage.

Applying **DICAMBA 700 SG** to sorghum during periods of rapid growth may result in temporary leaning of plants or rolling of leaves. These effects are usually outgrown within 10 to 14 days.

Preharvest uses in Texas and Oklahoma only: Apply up to 6 ounces of **DICAMBA 700 SG** per acre for weed suppression any time after the sorghum has reached the soft dough stage. Use an agriculturally approved surfactant to improve performance. For aerial applications, use at least 2 gallons of water-based carrier per treated acre. Delay harvest until 30 days after a preharvest treatment.

SPLIT APPLICATION

DICAMBA 700 SG can be applied in split applications: preplant followed by postemergence or preharvest; or postemergence followed by preharvest. **DO NOT** exceed 6 ounces per acre, per application or a total of 12 ounces per acre, per season.

Soybean

PREPLANT APPLICATIONS

Apply 3 to 12 ounces of **DICAMBA 700 SG** per acre to control emerged broadleaf weeds prior to planting soybeans.

DO NOT exceed 12 ounces of **DICAMBA 700 SG** per acre in a spring application prior to planting soybeans. Following application of **DICAMBA 700 SG** and a minimum accumulation of 1" rainfall or overhead irrigation, a waiting interval of 14 days is required for 6 ounces per acre or less, and 28 days for 12 ounces per acre. These intervals must be observed prior to planting soybeans or crop injury may occur.

DO NOT make **DICAMBA 700 SG** preplant applications to soybeans in geographic areas with average annual rainfall less than 25".

PREHARVEST APPLICATIONS

Apply **DICAMBA 700 SG** to control many annual and perennial broadleaf weeds, and to control or suppress many biennial and perennial broadleaf weeds in soybean prior to harvest (refer to **Table 1**). Apply 6 to 24 ounces of **DICAMBA 700 SG** per acre as a broadcast or spot treatment to emerged and actively growing weeds after soybean pods have reached mature brown color and at least 75% leaf drop has occurred.

Soybeans may be harvested 7 days or more after a preharvest application. Treatments may not kill weeds that develop from seed or underground plant parts, such as rhizomes or bulblets, after the effective period for **DICAMDA 700 SG**. For seedling control, a follow-up program or other cultural practice could be instituted.

DO NOT use preharvest-treated soybean for seed unless a germination test is performed on the seed with an acceptable result of 95% germination or better.

DO NOT feed soybean fodder or hay following a preharvest application of DICAMDA 700 SG.

DO NOT make preharvest applications in California.

Soybean Tank Mixes

PREPLANT TANK MIXES

Tank mix **DICAMBA 700 SG** with other herbicides registered for early preplant use in soybeans including burndown herbicides such as glyphosate (**Acquire®**, **Roundup Ultra®**) and 2,4-D or residual herbicides such as **Outlook®**, **Frontier®** or **Dual Magnum**[™].

PREHARVEST TANK MIXES

Tank mix **DICAMBA 700 SG** with other herbicides registered for preharvest use in soybeans such as glyphosate (**Roundup Ultra®**) and **Gramoxone® Extra**.

Sugarcane

Apply **DICAMBA 700 SG** to control annual, biennial, or perennial broadleaf weeds listed in **Table 1.** Apply 6 to 17 ounces of **DICAMBA 700 SG** per acre for control of annual weeds, 12 to 24 ounces for control of biennial weeds, and 24 ounces to control or suppress perennial weeds.

Use the higher level within the specified rate range when treating dense vegetative growth. Retreat as needed; however, **DO NOT** exceed a total of 48 ounces of **DICAMBA 700 SG** per treated acre during a growing season.

Timing: Apply **DICAMBA 700 SG** to sugarcane any time after weeds have emerged, but before the close-in stage of sugarcane. Applications of 24 ounces of **DICAMBA 700 SG** per acre made over the top of actively growing sugarcane may result in crop injury. Direct the spray beneath the sugarcane canopy to minimize the likelihood of crop injury. Using directed sprays will also help maximize the spray coverage of weed foliage.

Sugarcane Tank Mixes

Tank mix **DICAMBA 700 SG** with other products registered for use in sugarcane such as **Asulox®**, atrazine, **Evik®**, and 2,4-D.

Farmstead Turf (non cropland) and Sod Farms

For use in farmstead (noncropland) and sod farms, apply 2 to 24 ounces of **DICAMBA 700 SG** per acre to control or suppress growth of many annual, biennial, and some perennial broadleaf weeds commonly found in turf. **DICAMBA 700 SG** will also suppress many other listed . perennial broadleaf weeds and woody brush and vine species. Refer to **Table 2** for rates based on targeted weed or brush species and growth stage. Some weed species will require tank mixes for adequate control.

Retreat as needed; however, **DO NOT** exceed 24 ounces of **DICAMBA 700 SG** per acre, per growing season. Apply 30 to 200 gallons of diluted spray per treated acre (3 to 17 quarts of water per 1,000 square feet), depending on density or height of weeds treated and on the type of equipment used.

To avoid injury to newly seeded grasses, delay application of **DICAMBA 700 SG** until after the second mowing. Furthermore, applying more than 12 ounces of **DICAMBA 700 SG** per treated acre may cause noticeable stunting or discoloration of sensitive grass species such as bentgrass, carpetgrass, buffalograss, and St. Augustinegrass.

In areas where roots of sensitive plants extend, **DO NOT** apply more than 3 ounces of **DICAMBA 700 SG** per treated acre on coarse-textured (sandy-type) soils, or in excess of 6 ounces per treated acre on fine-textured soils. **DO NOT** make repeat applications in these areas for 30 days and until previous applications of **DICAMBA 700 SG** have been activated in the soil by rain or irrigation.

Farmstead Turf (non cropland) and Sod Farms Tank Mixes

Apply 3 to 6 ounces of **DICAMBA 700 SG** per acre in a tank mix with one of the products in **Table 9** at the rates listed. Use the higher rates within the specified rate range when treating established weeds.
