c. Delete the heading "Statement of Practical Treatment" and replace it with the heading "FIRST AID." In addition, separate the first aid statement heading from the child signal word "Keep out Of Reach of Children-DANGER."

d. Add the following statement at the bottom of the first statement:

"Have the product container or label with you when calling a poison control center or doctor, or going for treatment. You may also contact 1-800-xxx-xxxx for emergency medical treatment."

e. Add the word "Pesticide" to the Storage and Disposal" heading in the storage and disposal section.

f. Remove the heading "DIRECTIONS FOR USE" and its instructions statement "It is a violation of Federal law to use this product in a manner inconsistent with its labeling" and place the heading and statement on the third page of the label above the heading "PRODUCT USE."

3. Submit three (3) copies of the final printed label prior to releasing this product for sale.

Apply by foaming or dripping onto fruit, brush for 15 to 30 seconds. Do not exceed one minute exposure. Follow by fresh water rinse. When diluted as directed HDH Foam 26 provides a 1.94% Sodium Orthophenate Tetrahydrate solution.
