- 1. The optional marketing claim "For dogs and puppies over 7 weeks of age weighing 11 to 20 lbs" must be made a mandatory statement, right below the product name. The relationship between package size and age and weight of the dog must be clear on the outer label.
- 2. On page 7, explain integrated flea management system, or delete this statement from alternative marketing text.


Attach these stickers to your wall calendar or day planner on the date you give the lirst dose of Product, and then place enother sticker on the same date for each of the next two months.
