



- 2. Remove the applicator tube from the package.
- 3. Holding the applicator tube upright, pointing away from you and your cat's face, place your thumb and index finger around the applicator tip under the large disk. With the other hand, grasp the stem of the applicator tip above the small disk. Press down firmly on the small disk until both disks meet, piercing the seal. (See illustration)



4. 










Example pictograms of flea and flea larvae
