Revised label dated May 19, 2014, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is accepted subject to the comments listed below:

- 1. Submit the final printed label with a clear picture of a dog in each weight range for the product as packaged on front panel of the label, plus other graphics and pictures.
- 2. This registration is now time-limited and expires two years from the date of this letter.
- 3. Please consider limiting the formulations of this product to one basic confidential statement of formula. The Agency may require this in the future and no additional alternate formulations or minor formulation amendments will be approved for this product in the future.
- 4. You must submit quarterly enhanced incident reports and quarterly sales information in doses sold for this product beginning [January 1, April 1, July 1, or October 1, whichever date most closely follows the date of the letter].

Please flag any Confidential Business Information as such. Enhanced incident reporting should be submitted to the Product Manager. Quarterly sales information should be submitted to the Registration Division, Immediate Office (attn: Kaitlin Keller).




## **DIRECTIONS FOR USE**






#### **NEXT DOSE STICKERS AND REMINDER CALENDAR**


