

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not contaminate feed or foodstuffs. Do not apply in serving areas while food is exposed. Place bait only in areas that are inaccessible to children and pets.

Ants are attracted to and will feed on Uncle Albert's Super Smart™ Ant Bait until they die. The ants return to their nests after consuming the bait and feed their young and queen. When all the members of the colony have consumed the bait, the entire colony will die.

Uncle Albert's Super Smart™ Ant Bait may be placed around and under areas where ants are trailing or have been seen crawling, including food cabinets, sinks, stoves, refrigerators, food storage areas, window sills, and frames (as well as exterior window sills and doorways to help prevent entry of ants), openings around pipes, baseboards, attics, garages, basements, storage areas, and closets.

FOR USE WITH BAIT CONTAINERS AND BAIT STATIONS: Wash hands thoroughly before handling bait containers and bait stations to remove any odors that may repel ants (i.e. tobacco, garlic, strong chemicals or cleaners, etc.). Fill bait containers with 0.25 oz. of Uncle Albert's Super Smart Ant Bait and place on the floor or on a flat surface in areas where ants may crawl.

FOR DIRECT PLACEMENT: (Not for Use in California) Make small, pea sized placements and/or thin lines of Uncle Albert's Smart Ant Bait in areas where ants may crawl. Long thin lines allow many ants to feed on the bait.

FOOD AREA APPLICATION LIMITED TO CRACK AND CREVICE TREATMENT ONLY: Do not use in food/feed areas of food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared or processed, Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms but excluding areas where food may be prepared or held.

Non-food/feed areas of food/feed areas such as garbage rooms, lavatories, floor drains (to sewers) entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after bottling or canning). In the home, cover all food handling surfaces and cover or remove all food and cooking utensils, or wash thoroughly after treatment.

Repeat placement of the bait as necessary until satisfactory results have been obtained. Do not use sprays, foggers or any strong chemicals or cleaners near the bait containers or placements. This may contaminate the bait and cause ants to cease feeding. Place bait stations and other placements on a flat surface only in areas inaccessible to children and pets.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store product in original container in a cool dry place out of reach of children. Do not allow product to freeze.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Nonrefillable Container. Do not reuse or refill this container. Place in trash or offer for recycling. Triple rinse container promptly after emptying.

[Optional Directions For use with cardboard, paper or foil squares.

The bottle is packaged in a display carton that contains cardboard squares roughly 1.5 in x 1 in. The squares are printed with "PLACE [PRODUCT NAME] HERE"]

FOR DIRECT PLACEMENT: Apply drops to cardboard from carton or small pieces of paper or foil. Place product where ants are seen, such as window sills, under food cabinets, along floor baseboards and in corners. [Continue with the main "For Direct Placement" directions]
