After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

Should you wish to add/retain a reference to your company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by EPA. - Use in the manufacture of plastic sheeting (film) to protect it from subterranean termites and ants. Incorporate **Sharda Bifen 2% MP** into plastic sheeting to a maximum concentration of 0.1% w/w and a minimum thickness of 0.5 mm.

Formulators using this product are responsible for obtaining U.S. EPA registration for their formulated product which may be labeled for the use patterns as found on this label.

STORAGE AND DISPOSAL
