If, after formal consultation with the appropriate Service(s), additional modifications are identified in the Service's Biological Opinion(s) for clothianidin, EPA will notify Sharda USA, LLC in writing consistent with the terms in the Biological Opinion of any necessary required changes. Sharda USA, LLC must submit an application for amendment incorporating any required changes, including amended labels, consistent with the timeline specified in EPA's notification. If Sharda USA, LLC fails to comply with this term, Sharda USA, LLC has agreed in prior written acceptance on June 12, 2023 of these terms that EPA may cancel the registration under an expedited process under FIFRA 6(e).
- 4. Submit one copy of the final printed label for the record before you release the product for shipment.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. PRODUCT INFORMATION

Sharda Clothianidin 0.25% WG is a broad-spectrum insecticide, for control of listed insects infesting turfgrass, sod farms, landscape ornamentals, interior plantscapes and non-bearing fruit trees (including apple and pear) and nut trees (in landscapes). When applied as directed, **Sharda Clothianidin 0.25% WG** provides excellent and long residual insect control.

Use Restrictions:

- DO NOT use a foliar application of clothianidin (Sharda Clothianidin 0.25% WG) following a soil application of clothianidin.
- DO NOT apply more than 160 lbs. (0.4 lb. a.i.) of Sharda Clothianidin 0.25% WG per acre per calendar year.
- If the maximum season limit of clothianidin as mentioned above has been applied and pest populations require additional treatments, use another registered pesticide that is not in the neonicotinoid class of chemistry.
- **DO NOT** apply this product, by any application method, to linden, basswood or other *Tilia* species.

Plant Tolerance

Neither the manufacturer nor the seller has determined whether or not **Sharda Clothianidin 0.25% WG** can be used safely on all cultivars of plants listed on the label. **Sharda Clothianidin 0.25% WG** has been tested on many cultivars with no phytotoxicity observed at label rates. Since all plant species and their varieties and cultivars have not been tested for tolerance, it is recommended that a small number of plants be treated to make certain that no phytotoxicity occurs, prior to any large-scale application to plants. The end user assumes all risks arising from application of **Sharda Clothianidin 0.25% WG** in a manner inconsistent with its labeling. **Sharda Clothianidin 0.25% WG** can be blended just prior to application or co-applied with other crop management tools. However, all plant species and their varieties and cultivars have not been tested with possible blended or co-applied combinations or sequential pesticide treatments. The user must conduct a small-scale compatibility and phytotoxicity trial under local conditions to ensure compatibility prior to any large-scale use.

It is the pesticide user's responsibility to ensure that all products are registered for the intended use. Read and follow the applicable restrictions and limitations and directions for use on all product labels involved in tanks mixing. Users must follow the most restrictive directions for use and precautionary statements of each product in the tank mixture.

INSECT RESISTANCE MANAGEMENT

For resistance management, Sharda Clothianidin 0.25% WG contains a Group 4A insecticide.

Any insect population may contain individuals naturally resistant to **Sharda Clothianidin 0.25% WG** and other Group 4A insecticides. The resistant individuals may dominate the insect population if this group of insecticides are used repeatedly in the same fields. Appropriate resistance-management strategies must be followed.

To delay insecticide resistance, take the following steps:

- Rotate the use of **Sharda Clothianidin 0.25% WG** or other Group 4A insecticides within a growing season, or among growing seasons, with different groups that control the same pests.
- Use tank mixtures with insecticides from a different group that are equally effective on the target pest when such use is permitted. **DO NOT** rely on the same mixture repeatedly for the same pest population. Consider any known cross-resistance issues (for the targeted pests) between the individual components of a mixture.
- In addition, consider the following recommendations provided by the Insecticide Resistance Action Committee (IRAC):
 - Individual insecticides selected for use in mixtures should be highly effective and be applied at the rates at which they are individually registered for use against the target species.
 - Mixtures with components having the same IRAC mode of action classification are not recommended for insect resistance management.
 - When using mixtures, consider any known cross-resistance issues between the individual components for the targeted pest(s).
 - Mixtures become less effective if resistance is already developing to one or both active ingredients, but they may still
 provide pest management benefits.
 - The insect resistance management benefits of an insecticide mixture are greatest if the two components have similar periods of residual insecticidal activity. Mixtures of insecticides with unequal periods of residual insecticide activity may offer an insect resistance management benefit only for the period where both insecticides are active.
- Adopt an integrated pest management program for insecticide use that includes scouting, uses historical information related to pesticide use, crop rotation, record keeping, and which considers cultural, biological, and other chemical control practices.
- Monitor after application for unexpected target pest survival. If the level of survival suggests the presence of resistance, consult with your local university specialist or certified pest control advisor.
- Contact your local extension specialist or certified crop advisors for any additional pesticide resistance-management and/or IPM recommendations for the specific site and pest problems in your area.

COMMERCIAL AND RESIDENTIAL LANDSCAPE USES

Sharda Clothianidin 0.25% WG is for use on landscape ornamentals, interior plantscapes and non-bearing fruit trees (including apple and pear) and nut trees (in landscapes). Sharda Clothianidin 0.25% WG should be applied when threshold populations are observed. DO NOT wait until large insect populations have been established. Apply to established plants. For control of pests on established plants, irrigate the treated area thoroughly. Choose lower rates for light infestations and/or smaller plants and higher rates for heavy

infestations and/or larger plants.

Application Methods:

Sharda Clothianidin 0.25% WG is a systemic and soil active insecticide when applied to the soil.

Residential Landscapes and In-ground Plants: For flower beds, broadcast **Sharda Clothianidin 0.25% WG** evenly over the top of plants. For treatment of individual shrubs or trees, broadcast **Sharda Clothianidin 0.25% WG** evenly on soil around base of plant within 18 inches of the trunk. Pull back mulch prior to application if mulch is more than 1 inch thick. Irrigate after application with enough water to dissolve granules and move product into root zone.

Restriction:

DO NOT apply more than 160 lbs. (0.4 lb. a.i.) of Sharda Clothianidin 0.25% WG per acre per calendar year.

Sharda Clothianidin 0.25% WG is a systemic insecticide and must move to the area of the plant where the target pest is feeding. Control of pests may be delayed following an application for 1 or more weeks as **Sharda Clothianidin 0.25% WG** moves to the feeding site. Factors including plant size, soil type and water demands will impact the time between application and obvious insect control.

Restrictions:

- DO NOT apply more than 160 lbs. (0.4 lb. a.i.) of Sharda Clothianidin 0.25% WG per acre per calendar year.
- Non-bearing fruit and nut trees in landscapes are only for ornamental use.
- **DO NOT** harvest fruit and nuts from treated trees within 1 year of application.
- This product may be blended just prior to application or co-applied with other compatible insecticides.

TURFGRASS

Sharda Clothianidin 0.25% WG can be used as directed on grass grown in industrial, commercial, and residential landscapes including, airports, athletic fields, cemeteries, commercial sod farms, golf courses, home lawns, parks, and playgrounds.

Sharda Clothianidin 0.25% WG has sufficient residual activity to provide high levels of control when applications are made proceeding or during the egg laying activity of the target pests. The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Follow applications with sufficient irrigation or rainfall to move the active ingredient through the thatch.

Sharda Clothianidin 0.25% WG can be applied to turf at 80 - 160 lbs. per acre. The rate is dependent on the target pest(s), their

stage of development and the desired of control. Multiple applications can be made but **DO NOT** exceed the maximum amount per year (160 lbs. per acre). Consult your local State Agricultural Experiment Station, State Extension Turf Specialists or other turf experts for specific information concerning the timing of application(s). When targeting multiple pests, make application to earliest egg lay or adult flight. The high end of the rate range may be needed if extended control of secondary pests are desired.

Apply **Sharda Clothianidin 0.25% WG** as a broadcast application to turfgrass for control of targeted pests. Use a calibrated spreader to uniformly broadcast **Sharda Clothianidin 0.25% WG** over the treatment area. **DO NOT** mow turfgrass until after irrigation or rainfall has occurred to allow for the uptake and distribution of **Sharda Clothianidin 0.25% WG** in soil and turfgrass
