2. A Generic Data Call-In (GDCI-129131-1501) for fenpyroximate was issued for data needed to conduct the registration review risk assessments. Based on the results of the Tier I (laboratory) honeybee data and other lines of evidence described in the Draft Ecological Risk Assessment for Fenpyroximate, EPA has determined that additional pollinator data are needed for fenpyroximate.
