- 3. Make the following label changes:
  - A. Add the phrase "EPA Registration No.83558-12" to the label and the Establishment Number before you release the product for shipment.
  - B. Add the "Net Weight" to the labeling prior to releasing this product for shipment.
  - C. Add a "Note to Physician" which addresses the category I Primary Eye Irritant Toxicity: i.e., -technical information on symptomatology; -use of supportive treatments to maintain life functions; -medicine that will counteract the specific physiological effects of the pesticide; -company telephone number to specific medical personnel who can provide specialized medical advice.
  - D. Revise the "Precautionary Statement on page 2, that reads: "Wash thoroughly with soap and water after handling" to read: "Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco.".
  - E. Preface the "Conditions of Sales and Limitation of Warranty" statement that reads: "In no event shall the Seller's ......".; with the clause: "To the extent consistent with applicable law".
- 4. Submit one (1) copy of the final printed labeling before you release this product for shipment.
