Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times.

Offer drum for recycling if available. If drum is contaminated and cannot be reused, dispose of in a sanitary landfill or by incineration, or if allowed by State and local authorities, by burning. If the drum is disposed of by burning, stay out of smoke.
