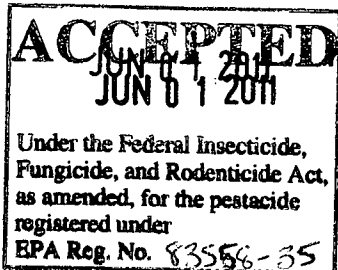

Pests – Indoors, Uses In: Industrial, Institutional and Commercial Buildings including Restaurants, Food Handling Establishments, Warehouses, Stores, Hotels, Manufacturing Plants and Ships.

Terrestrial Food, Uses On: Beans and Lima Beans [**Restriction:** Use on Succulent green beans is prohibited (includes string beans, snap beans and wax beans)], Brussels Sprouts, Cauliflower, Celery, Cranberries, Cotton, Cottonseed, Head Lettuce, Macadamia Nuts, Peanuts, Peppermint, Peppers, Soybeans, Sweet Peppers, and Spearmint.
