


4. In the "First Aid" statement of the label append "Or Clothing" to allow: "If On Skin Or Clothing."
5. "Precautionary Statements" section of the label, immediately following the signal word, revise the fifth sentence to read: "Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using toilet."
6. "Storage and Disposal" section of the label requires the completion of the sub-section "Pesticide Storage."
 - a. To this sub-section, insert: "Store in original container only, in a cool, dry area. Keep container tightly closed when not in use. Avoid cross contamination with other pesticides."
7. Under the section "Conditions of Sale and Limitation of Warranty," to the second sentence, append "To the extent permitted by applicable law buyer assumes the risk...such directions." In the final sentence, append "To the extent consistent with applicable law...claim is made."
