### Dear Ms. Tillman:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made:

- 1) On your product label, please add the following specific crop stipulations, as seen on the label of the product you referenced (EPA Reg. No. 83851-10)
  - a) Next to "cranberries" add "OR, WA, and WI only"
  - b) Next to "Pineapple" add "HI only"
  - c) Next to "Grasses grown for seed" add "ID, MN, NE, OR and WA only"
  - d) Next to "Wild Rice" add "MN only"
- 2) In your warranty statement, revise all places which read "to the extent allowed by state law" to read "to the extent consistent with applicable law". Please also see http://www.epa.gov/oppfead1/labeling/lrm/chap-12.htm#IX for further guidance.
- 3) Under your Environmental Hazards statement, revise the first sentence to read "This product is toxic to fish and shrimp".
- 4) In your Hazards statement, move "Harmful if swallowed" so that it appears after the sentence "Wear protective eyewear (goggles, face shield or safety glasses)".
