- 2. Rewrite your "Precautionary Statement" adding ...chewing gum, using tobacco or using the toilet.
- 3. Add yearly product usage language on the label. Do not apply more than 16 lbs of Turfthor 0.5 G. (2.5 lbs) of active ingredient per acre per year for any types or combination or applications.
- 4. On page 2 change the header from "Attention" to "Restrictions" The header "Attention" may mislead users to believe the following language is advisory instead of mandatory.
- 5. Should you wish to add/retain a reference to the company's website on your label, please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. Hazards to Humans and Domestic Animals

CAUTION

Environmental Hazards

This pesticide is highly toxic to aquatic invertebrates. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters.

The properties and characteristics of this chemical are similar to those of agrochemicals that have been detected in groundwater. APPLICATION FOR ORNAMENTAL PESTS

TURFTHOR 2.5 G, broadcast on the ground, controls a wide range of insects on small trees (including non-bearing fruit and nut trees) (up to 8 ft. in height) and ornamental shrubs in outdoors landscapes and interior plantscapes. Non-bearing trees are perennial plants that will not produce a harvestable agricultural commodity within the next 12 months. TURFTHOR 2.5 G is not for use on plants being grown for sale, fruit, nut or commercial seed production or for research purposes.

TURFTHOR 2.5 G is a systemic insecticide meaning it will be translocated by the plant's vascular system from the roots up into the body of the plant. This means optimum effectiveness of TURFTHOR 2.5 G is realized when TURFTHOR 2.5 G is applied on the ground above the root zone of the plant to be protected. Watering after application can speed movement of the active ingredient into the plant's vascular system. Combining TURFTHOR 2.5 G with a nitrogen containing fertilizer may further accelerate or otherwise enhance the uptake of the active ingredient into the plant.

Translocation of soil directed applications made to woody stemmed plants can be delayed by up to 60 days. Optimum levels of control are realized when applications are performed sufficiently prior to anticipated pests infestations.

Application Sites

For use on small trees (up to 8 feet in height) and shrubs. For trees taller than 8 feet, use other TURFTHOR products approved for such use.

Application Timing

Make initial application before pest attack if attack is anticipated. Otherwise apply when pests are found attacking. Re-apply if needed based on continued infestation or re-infestation at intervals of 4-8 weeks between applications.

If necessary, consult resources in horticulture in your area (such as your Cooperative Extension Service) to determine appropriate application timing.

Application Precautions and Preparations

Avoid application to areas in which penetration to the root zone is unlikely to occur such as areas that are waterlogged, saturated or frozen.

TURFTHOR 2.5 G can be mixed with other granular insecticides, mitticides, fungicides, herbicides and fertilizers. Follow the label directions of all the products mixed, making sure not to exceed the labeled application rate of any individual product in the mixture.

Post Application Watering

Optimum control is achieved if irrigation or rainfall occurs within 24 hours after application.

Application Method

Apply TURFTHOR 2.5 G by spreading on the ground at and around the base of the tree or shrub.

Broadcast Application Use Rate

Up to 4 feet = 1/4 cup to 1/2 cup

4 feet to 8 feet = 1/2 cup to 1 cup

APPLICATION FOR ANT MANAGEMENT

Apply Turfthor 2.5 G according to the application instructions above to control aphids and other sucking insect pests of ornamentals in order to limit the amounts of honeydew available as a food source for ants. Supplement the use of Turfthor 2.5 G for this purpose with other ant control and management techniques and products.

Do not apply near fish pools, ponds, streams or lakes. Do not use in vegetable gardens.
